Amend SS/Senate Bill No. 117, Page 1, Section A, Line 4,

2 by inserting after all of said line the following: 3 "442.592. 1. For the purposes of this section, the 4 term "foreign person" means: (1) An individual who is not a citizen of the United 5 States and who has not been lawfully admitted to the United 6 7 States for permanent residence under the Immigration and 8 Nationality Act or who has not been made a citizen by an act 9 of Congress; (2) An entity, other than an individual or a 10 government, that is created or organized under the laws of a 11 12 nation other than the United States, or that has its 13 principal place of business in a foreign nation; (3) An entity, other than an individual or a 14 15 government, that is created or organized under the laws of 16 the United States or of some state, territory, trusteeship or protectorate of the United States and that, as defined in 17 regulations to be prescribed by the director, is 18 substantially controlled by individuals referred to in 19 20 subdivision (1) of this subsection, entities referred to in 21 subdivision (2) of this subsection, governments of foreign 22 nations, or any combination of such individuals, entities, 23 or governments; and 24 (4) A government of a foreign nation. 25 2. Any foreign person who holds any interest (including leaseholds of ten or more years and beneficial 26

- 27 interests in the agricultural land under contracts of sale
- 28 or similar arrangements), other than a security interest, in
- 29 agricultural land on September 28, 1979, shall submit, or
- 30 have a designated agent submit, a report to the director of
- 31 agriculture not later than sixty days after September 28,
- 32 1979; provided, however, that no reporting requirement
- 33 attaches to any holding by an alien or a foreign person or a
- 34 foreign business of an interest in agricultural land for the
- 35 extraction, refining, processing or transportation of oil,
- 36 gas, coal or lignite. Such report shall be submitted in
- 37 such manner as the director shall prescribe by regulation
- 38 and shall contain:
- 39 (1) The legal name and address of the foreign person;
- 40 (2) In any case in which the foreign person is an
- 41 individual, the citizenship of the foreign person;
- 42 (3) In any case in which the foreign person is not an
- 43 individual or a government:
- 44 (a) The nation in which the foreign person is created
- 45 or organized;
- 46 (b) The principal place of business of the foreign
- 47 person;
- 48 (c) The legal name and address of each person who
- 49 holds a substantial interest (as defined in regulations to

- 51 any case in which the holder of such an interest is an

- 62 (6) The date of acquisition of the interest and the 63 purchase price paid for, or any other consideration given 64 for, the interest;
- 65 (7) A declaration of the type of agricultural activity 66 engaged in by the reporting foreign person;
- 67 (8) In the case where any foreign person holds an
 68 interest in agricultural land for the purposes outlined in
 69 section 442.591, a declaration of intent as to the intended
 70 use of the land.
- 3. No rule or portion of a rule promulgated under the authority of sections 442.560 to 442.591 shall become effective unless it has been promulgated pursuant to the provisions of section 536.024.
- 75 4. Any foreign person who acquires or transfers any interest (including leaseholds of ten years or more and 76 77 beneficial interests in the agricultural land under contracts of sale or similar arrangements), other than a 78 79 security interest, in agricultural land shall submit, or have a designated agent submit, a report to the director not 80 later than thirty days after the date of such acquisition or 81 82 transfer; provided, however, that no reporting requirement attaches to an acquisition or transfer by an alien or a 83 84 foreign person or a foreign business of an interest in agricultural land for the extraction, refining, processing, 85 or transportation of oil, gas, coal or lignite. Such report 86 shall be submitted in such manner as the director shall 87 prescribe by regulation and shall contain: 88
 - (1) The legal name and address of the foreign person;
- 90 (2) In any case in which the foreign person is an 91 individual, the citizenship of the foreign person;

- 92 (3) In any case in which the foreign person is not an 93 individual or a government:
- 94 (a) The nation in which the foreign person is created 95 or organized;
- 96 (b) The principal place of business of the foreign97 person;
- The legal name and address of each person who 98 (C) 99 holds a substantial interest (as defined in regulations to 100 be prescribed by the director) in the foreign person and, in 101 any case in which the holder of such an interest is an 102 individual, the citizenship of the holder and, in any case 103 in which the holder of such an interest is not an individual 104 or a government, the nation in which the holder is created 105 or organized and the principal place of business of the 106 holder;
- 107 (4) The type of interest in the agricultural land that
 108 is acquired or transferred by the foreign person;
- 109 (5) A legal description of the agricultural land 110 including the county in which the land is located and the 111 total acreage involved;
- 112 (6) The purchase price paid or received for, or any 113 other consideration given or received for, the interest;
- 114 (7) In any case in which the foreign person transfers 115 the interest, the legal name and the address of the person 116 to whom the interest is transferred, and
- 117 (a) In any case in which the transferee is an 118 individual, the citizenship of the transferee; and
- 119 (b) In any case in which the transferee is not an
 120 individual or a government, the nation in which the
 121 transferee is created or organized and the principal place
 122 of business of the transferee;
- 123 (8) A declaration of the type of agricultural activity 124 engaged in by the reporting foreign person;

- 125 (9) In the case where any foreign person acquires an
 126 interest in agricultural land for the purposes outlined in
 127 section 442.591, a declaration of intent as to the intended
 128 use of the land.
- 5. The director may promulgate rules and regulations
 pertaining to the form and content of reports required by
 this section; the procedures for filing such reports; and
 the analysis and distribution of findings and determinations
 based on the reports required by this section.
- 134 6. (1) The director shall:
- 135 (a) Analyze the information obtained under this
 136 section and determine the effects of foreign persons
 137 acquiring, transferring and holding agricultural land,
 138 particularly the effects of such acquisitions, transfers and
 139 holdings on family farms and rural communities; and
- 140 (b) Transmit to the governor and each house of the 141 general assembly a report on the director's findings and 142 conclusions regarding each analysis and determination made 143 under paragraph (a) above;
- 144 (2) An analysis and determination shall be made, and a 145 report on the director's findings and conclusions regarding 146 such analysis and determination transmitted:
- (a) With respect to information obtained by the director under this section during the six-month period following September 28, 1979, within nine months after such date;
- 151 (b) With respect to information obtained by the
 152 director under this section during the twelve-month period
 153 following September 28, 1979, within fifteen months after
 154 such date; and
- (c) With respect to each calendar year following the twelve-month period referred to in paragraph (b), within ninety days after the end of such calendar year.

7. Any foreign person who fails to file a report 158 required under the provisions of this section is liable to 159 the state in civil penalty. The civil penalty shall be 160 determined by the circuit court in an amount not to exceed 161 twenty-five percent of the fair market value of the interest 162 163 in agricultural land with respect to which the violations occurred on the date of the assessment of the penalty. 164 165 attorney general shall recover the amount of any civil 166 penalty assessed in a civil action in the circuit court in 167 the county in which any part of the land involved is 168 located. Any civil action by the attorney general brought 169 pursuant to this section shall be filed within ten years of the discovery of the failure to file a report as required by 170 the provisions of this subsection."; and 171 172 Further amend the title and enacting clause accordingly.
