APENDIX

Comments Received from Public on Department of Health and Senior Services Rules

1. 19 CSR 30-1.064 Partial Filling of Controlled Substance Prescriptions

The Department received a comment from Mary Cremer regarding 19 CSR 30-1.064. This rule allows for the partial filling of a controlled substance prescription listed in Schedule II in situations where the pharmacist is unable to supply the full quantity called for in a written prescription. However, the remaining portion of the prescription may be filled within seventy-two (72) hours. If the remaining portion of the prescription is not filled within 72 hours, a new prescription must be obtained. Mary Cremer notes that this rule makes it difficult for patients to get their controlled substance prescriptions filled. Mary Cremer notes that the rule causes an undue hardship in that it requires the patient to go see their doctor again to obtain another prescription if the remaining portion cannot be filled within 72 hours. She also states that pharmacists should be given the autonomy to make the decisions that are best for the individuals who are dependent on these medications for their quality of life. Mary Cremer suggests that this rule should be rescinded.

Response from the Department – This regulation is largely patterned after a federal DEA regulation (21 CFR 1306.13). With respect to controlled substances, states are generally allowed to be stricter with their controlled substance laws, but states cannot adopt laws or regulations that otherwise conflict with federal statutes or federal regulations. In July 2023, the DEA amended its rule regarding the partial filling of prescriptions for schedule II substances. The amended federal rule now allows the partial filling of a prescription for a schedule II substance at the request of either the prescribing practitioner or a patient. The newly amended 21 CFR 1306.13 enables physicians or patients to request pharmacists to partially fill prescriptions for schedule II substances and to allow remaining quantities to be filled up to 30 days after issuance of the prescription. However, the federal regulation continues to make a distinction between partial fills where there is not a sufficient supply on hand and partial fills specifically requested by a patient or physician. With respect to situations where a pharmacist is unable to supply the full quantity called for in the original prescription because there is an insufficient supply on hand, the federal rule still requires the remaining portion of a schedule II substance to be filled within 72 hours. While the Department is currently amending this rule to address the changes made to the federal rule, the Department is unable to modify the current rule in a manner which would address the commenter’s concerns.

2. 19 CSR 20-20.030 Exclusion From School and Readmission

The Department received a comment from Deborah Wiersma regarding 19 CSR 20-20.030. She requested that the Department rescind this rule noting that the rule prevents an unvaccinated child, who is believed to be “liable to transmit” a disease that is on the list of those “reportable” to DHSS, from attending school during an outbreak of a communicable disease.

Response from the Department: Section 192.020, RSMo requires the Department of Health and Senior Services to safeguard the health of the people in the state and all its subdivisions. Further, section 192.030, RSMo, requires the Department to designate diseases which are infectious, contagious, communicable, or dangerous in their nature and make and enforce adequate orders,

findings, rule and regulations to prevent the spread of such diseases. The rules that the Department has set forth are the least restrictive in order to ensure that the Department's statutory requirement is met. No changes will be made to the rule as a result of this comment.

3. 19 CSR 10-10.110 Amending or Correcting Vital Records

The Department received a comment from Erika Woehlk regarding 19 CSR 10-10.110. Erika Woehlk asks the Department to amend a provision contained in this rule relating to death certificates which reads "*The medical information can be corrected only by the medical certifier, coroner, or medical examiner who certified the cause of death.*" Erika Woehlk would like to be able to amend or correct a death certificate in the same manner a birth certificate can be amended. She notes that medical information on a birth certificate or fetal death certificate can be changed by the medical certifier "*or personnel of the institution responsible for filing the certificate.*" Erika Woehlk requests that the Department change the rule so that "personnel of the institution responsible for filing the certificate," be added to those who can amend a cause of death on a death certificate.

Response from the Department - The current rule exists to preserve the integrity of the most significant and valuable portion of the Certificate of Death—the medical certification. After careful consideration for the underlying policy rationale for this portion of the rule, no change will be made to this rule as a result of this comment.

4. 19 CSR 20-28.010 Immunization Requirements for School Children

19 CSR 20-28.040 Day Care Immunization Rule

19 CSR 20-28.060 Minimum Immunization Coverage to Be Provided by Individual and Group Health Insurance Policies

A. The Department received an email from Michael Westin requesting that Division 20—Division of Community and Public Health, Chapter 28—Immunization be rescinded in its entirety. Mr. Westin notes that the national/federal level departments and agencies that release vaccine requirements and recommendations are in violation of the 10th Amendment of the U.S. Constitution by their mere existence. Since the constitution does not expressly grant the federal government power to regulate education or the medical field, all issues pertaining to education and the medical field shall be reserved for each state to decide for themselves. For this reason, Mr. Westin states that Missouri should set its own vaccine schedule that's in line with how Missouri citizens feel about this issue, and solely reference that schedule. He further notes that this is why Missouri should not use any schedule released by the WHO, CDC, DoE, ACIP, or any other such federal level agency or department. Mr. Westin notes that a top-down "cookie cutter" approach is not the best way to decide issues that should be state-level issues. Mr. Westin holds that the rules set forth in Division 20, Chapter 28 conflict with the Constitution. He also notes that the choice to vaccinate or not to vaccinate students, should solely belong to the parents or legal guardians of the students. According to Mr. Westin, due to the increase in vaccine technology and remote learning technology, the rules contained in Division 20, Chapter 28 are obsolete. He also notes that these rules impose an unreasonable regulatory burden on individuals, school administrators, and state employees. Mr. Westin suggests that rescinding the rules would eliminate unnecessary paperwork.

In lieu of repealing Division 20, Chapter 28, Mr. Westin also suggests several modifications to the rules. With respect to 19 CSR 20-28.010, Mr. Westin suggests that the purpose be amended to read “This rule establishes minimum immunization requirements for all students in public schools.”

Response from the Department: The Missouri Department of Health and Senior Services is required pursuant to §167.181, RSMo to set forth specific immunizations for all children attending public, private, parochial or parish schools. Additionally, the Department of Health and Senior Services is required to follow the recommendation of the ACIP and the Centers for Disease Control recommendations for Day Care, preschool, and nursery school immunizations under §210.003, RSMo., as this is the requirement for day cares the Department of Health and Senior Services has chosen to continue to follow those recommendations for children attending elementary and secondary school as well. No changes will be made to the rule as a result of this comment.

- B. With respect to 19 CSR 20-28.010(1), Mr. Westin suggests that the rule be amended to remove “private, parochial, or parish” from the list of schools that must submit a summary report to the Department of Health and Senior Services.

Response from the Department: The Missouri Department of Health and Senior Services is required pursuant to §162.181, RSMo to set forth specific immunizations for all children attending public, private, parochial or parish schools. Additionally, the statute requires superintendents of each of these types of schools to report this information to the Department of Health and Senior Services. No change is being made to the rule as a result of this comment.

- C. With respect to 19 CSR 20-28.010(1)(B), Mr. Westin suggests that the rule be amended to remove “private, parochial, or parish” from the list of schools the rule is designed to govern.

Response from the Department: The Missouri Department of Health and Senior Services is required pursuant to §167.181 to set forth specific immunizations for all children attending public, private, parochial or parish schools. Additionally, the statute requires superintendents of each of these types of schools to report this information to the Department of Health and Senior Services. No change is being made to the rule as a result of this comment.

- D. With respect to 19 CSR 20-28.010(2), Mr. Westin suggests that the rule be amended to read, “Review of immunization requirements for school entry shall be conducted annually by each school superintendent or designee. Age or grade-appropriate vaccine requirements shall be according to State legislators.” Thus removing “the Missouri School Immunization Requirements Vaccines Received 0–18 Years of Age, published on April 2014 or the Centers for Disease Control and Prevention’s Catch-up Immunization Schedule for Persons Aged 4

Months through 18 Years Who Start Late or Who Are More Than 1 Month Behind, published January 2014. “

Response from the Department: The Department of Health and Senior Services has chosen to follow the recommendations of the ACIP and the Centers for Disease Control for children attending elementary and secondary school, as it is required to follow the recommendation of the ACIP and the Centers for Disease Control recommendations for Day Care, preschool, and nursery school immunizations under §210.003, RSMo. No change is being made to the rule as a result of this comment.

- E. With respect to 19 CSR 20-28.040, Mr. Westin suggests that the purpose provision be amended to read, “This rule establishes immunization requirements in accordance with state legislators for all children attending public day care, preschool or nursery schools caring for fifty or more children, and describes actions to be taken to ensure compliance with section 210.003, RSMo.” Essentially, the commenter is suggesting the removal of the Advisory Committee on Immunization Practices recommendations, removing private or parochial daycares, and changing the number of students in a school from ten to fifty.

Response from the Department: Section 210.003, RSMo., sets the number of students at ten and sets forth that the immunization requirements are for all public, private, and parochial day care centers, preschools, and nursery schools. No changes to the rule will be made as a result of this comment.

- F. With respect to 19 CSR 20-28.040(1), Mr. Westin suggests removing “private, or parochial” from the list of daycares and changing the number of students cared for from 10 to 50.

Response from the Department: Section 210.003, RSMo., sets the number of students at ten and sets forth the immunization requirements are for all public, private, and parochial day care centers, preschools, and nursery schools. Additionally, Section 210.003, RSMo., requires the Department of Health and Senior Services to utilize the Centers for Disease Control and Prevention Advisory Committee on Immunization Practices (ACIP) when setting the list of immunizations required. No changes were made to the rule as a result of this comment.

- G. With respect to 19 CSR 20-28.040(2), Mr. Westin suggests removing “private, or parochial” from the list of daycares and changing the number of students cared for from 10 to 50. In addition, the commenter suggests removing the language “Missouri Day Care Immunization Requirements Vaccines Received 0-18 Years of Age or the Center for Disease Control and Prevention’s Catch-up Immunization Schedule for Persons Aged 4 Months through 18 Years Who Start Late or Who are More than 1 Month Behind”.

Response from the Department: Section 210.003, RSMo., sets the number of students at ten and sets forth the immunization requirements are for all public, private, and parochial day care centers, preschools, and nursery schools. Additionally, section 210.003, RSMo., requires the Department of Health and Senior Services to utilize the Centers for Disease Control and Prevention Advisory Committee on Immunization Practices (ACIP) when setting

the list of immunizations required. No changes were made to the rule as a result of this comment.

- H. With respect to 19 CSR 20-28.060(2), Mr. Westin suggests changing the rule to read, “All immunization within the Recommended Childhood Immunization Schedule—Missouri, approved by the Missouri legislature shall be required under this rule.” Thus changing the Immunization Schedule from the United States and removing “Advisory Committee on Immunization Practices (ACIP)” and removing “As the schedule is updated, it will be available from and distributed by the Department of Health. The immunizations required under this rule and manner and frequency of their administration shall conform to recognized standards of medical practice.”

Response from the Department: Section 210.003, RSMo., requires the Department of Health and Senior Services to utilize the Centers for Disease Control and Prevention Advisory Committee on Immunization Practices (ACIP) when setting the list of immunizations required. Additionally, section 167.181, RSMo., requires that immunizations be done by a duly licensed physician or by someone under his direction. No changes were made to the rule as a result of this comment.
