### Governor's State of the State Address

Last night in Reagan fashion, Governor Blunt spelled out how he was will shrink State Government and give power back to the people of Missouri. In his speech, Senator Loudon's legislation was prominently featured. Governor Blunt proclaimed that he wanted to see Workers' Comp reform, legislation to stop minors crossing the state border for an abortion, and tax credits for those who adopt. All these issues are in bills that Loudon pre- filed in December. They are SB1, SB2, and SB3. All three bills are sure to be signed because the Governor has made these issues a priority in his administration. Also laid out last night was the Governor's budget, which has proposed an increase in for education.

# Senate Bill 1 "Workers' Compensation Reform" headed to the Floor

SB 1 has been voted out of committee and will go to the floor before the full Senate. . The committee vote was split right along party lines 6 to 3. Senate Bill 1 will continue to foster an atmosphere friendly to business in Missouri. This atmosphere is the Governor's vision for Missouri and SB 1 should be signed into law.

## **Loudon hosts Press Conference for SLAPP Legislation**

The Senator called his first press conference today. In it he spelled out how a bi-partisan informal panel over the summer worked out new language for the law. This legislation will protect all citizens from being sued for using their right to free speech. The new wording also keeps the plaintiffs from suing, then withdrawing the suit after the defendant has incurred large attorney's fees. Loudon compared this to attackers lobbing a mortar round at their victims and then running for cover. Under this bill once someone is SLAPPED that individual would have a right to recovery.
