## AN ACT

To appropriate money for the expenses, grants, and distributions for several departments and offices of state government, and to transfer money among certain funds, from the funds designated for the fiscal period beginning July 1, 2006 and ending June 30, 2007.

*Be it enacted by the General Assembly of the State of Missouri, as follows:*

There is appropriated out of the State Treasury, to be expended only as  
2 provided in Article IV, Section 28 of the Constitution of Missouri, for the purpose  
3 of funding each department, division, agency, and program enumerated in each  
4 section for the item or items stated, and for no other purpose whatsoever  
5 chargeable to the fund designated, providing that no funding shall be expended  
6 to build and equip buildings and laboratories that would engage in activities  
7 defined under Section 196.1127 RSMo, for the period beginning July 1, 2006 and  
8 ending June 30, 2007, as follows:
