AN ACT

To repeal section 227.345, RSMo, and to enact in lieu thereof seven new sections relating to highway patrol member highway designations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 227.345, RSMo, is repealed and seven new sections
2 enacted in lieu thereof, to be known as sections 227.305, 227.345, 227.359,
3 227.375, 227.377, 227.379, and 227.384, to read as follows:

**227.305. The portion of state highway M within Washington
2 County which is located within the city limits of Irondale shall be
3 designated the "Trooper Robert Kolilis Memorial Highway". The
4 department of transportation shall erect and maintain appropriate
5 signs designating such highway, with the costs to be paid for by the
6 Missouri State Troopers' Association.**

227.345. The portion of interstate 44, **except for the portion of such
2 interstate designated under section 227.379**, located in a county of the third
3 classification without a township form of government and with more than
4 thirty-one thousand but less than thirty-one thousand one hundred inhabitants
5 shall be designated the "Edwin P. Hubble Memorial Highway".

**227.359. The bridges on state highway 60 crossing the Current
2 River that are located within the city limits of Van Buren shall be**

3 designated individually as the "Sgt. Dewayne Graham Jr. Memorial
4 Bridge MO State Highway Patrol". The bridges shall be collectively
5 designated as the "Sgt. Dewayne Graham Jr. Memorial Bridges MO
6 State Highway Patrol". The department of transportation shall erect
7 and maintain appropriate signs designating such bridges, with the
8 costs to be paid for by the Missouri State Troopers Association.

227.375. The portion of U.S. highway 54 located within Camden
2 County from the eastern city limits of Macks Creek to the western city
3 limits of Camdenton shall be designated the "Trooper Ross S. Creach
4 Memorial Highway". The department of transportation shall erect and
5 maintain appropriate signs designating such highway, with the costs
6 to be paid for by the Missouri State Troopers' Association.

227.377. The portion of U.S. Highway 60 from the intersection of
2 state route MM to the intersection of state highway 181 in Texas County
3 shall be designated the "Trooper D. Kevin Floyd Memorial
4 Highway". The costs for such designation shall be paid by the Missouri
5 Troopers' Association.

227.379. The portion of interstate highway 44 from mile marker
2 91 to mile marker 94, contained in Webster County, shall be designated
3 the "Cpl. Jay Sampietro MO State Hwy. Patrol Memorial Highway". The
4 department of transportation shall erect and maintain appropriate
5 signs designating such highway, with the costs to be paid for by the
6 Missouri state troopers' association.

227.384. The two-mile portion of interstate highway 44 heading
2 east from the U.S. Highway 50 intersection, contained in Franklin
3 County, shall be designated as the "Trooper Ralph Tatoian Memorial
4 Highway". The department of transportation shall erect and maintain
5 appropriate signs designating such highway, with the costs to be paid
6 for by the Missouri State Troopers Association.
