AN ACT

To repeal sections 50.339 and 54.040, RSMo, and to enact in lieu thereof two new sections relating to county officials.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 50.339 and 54.040, RSMo, are repealed and two new
2 sections enacted in lieu thereof, to be known as sections 50.339 and 54.040, to
3 read as follows:

50.339. 1. In any county of the first classification with more than
2 seventy-one thousand three hundred but less than seventy-one thousand four
3 hundred inhabitants, the salary commission at its meeting in 2003 and at any
4 meeting held in 2004 may equalize the base salary for each office to an amount
5 not greater than that set by law as the maximum compensation. Nothing in this
6 section shall be construed to prevent offices which have additional compensation
7 specified in law from receiving such compensation or from having such
8 compensation added to the base compensation in excess of the equalized salary.

9 2. Notwithstanding any provision of section 50.343, **50.333**, or **50.327** to
10 the contrary, in any county of the first classification with more than sixty-eight
11 thousand six hundred but less than sixty-eight thousand seven hundred
12 inhabitants, the salary commission may meet in the year [2004] **2007** to
13 determine whether to equalize the base salary for the office of treasurer **and**
14 **public administrator** with the base salaries of [other county officers at an

15 amount not greater than the amount set as the maximum compensation in
16 subdivision (1) of subsection 1 of section 50.343] **the offices of auditor and**
17 **recorder of deeds.**

54.040. 1. **A candidate for county treasurer shall be at least**
2 **twenty-one years of age and a resident of the state of Missouri and the**
3 **county in which he or she is a candidate for at least one year prior to**
4 **the date of the general election for such office. The candidate shall**
5 **also be a registered voter and shall be current in the payment of all**
6 **personal and real estate taxes. Upon election to such office, the person**
7 **shall continue to reside in that county during his or her tenure in**
8 **office.**

9 2. No sheriff, marshal, clerk or collector, or the deputy of any such officer,
10 shall be eligible to the office of treasurer of any county.
