AN ACT

To repeal section 644.021, RSMo, and to enact in lieu thereof one new section relating to membership on the clean water commission, with an emergency clause.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 644.021, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 644.021, to read as follows:

644.021. 1. There is hereby created a water contaminant control agency to be known as the "Clean Water Commission of the State of Missouri", whose domicile for the purposes of sections 644.006 to 644.141 shall be deemed to be that of the department of natural resources. The commission shall consist of seven members appointed by the governor with the advice and consent of the senate. No more than [three] four of the members shall belong to the same political party. All members shall be representative of the general interest of the public and shall have an interest in and knowledge of conservation and the effects and control of water contaminants. Two such members, but no more than two, shall be knowledgeable concerning the needs of agriculture, industry or mining 10 and interested in protecting these needs in a manner consistent with the 11 purposes of sections 644.006 to 644.141. One such member shall be 12 13 knowledgeable concerning the needs of publicly owned wastewater treatment 14 works. Four members shall represent the public. No member shall receive, or 15 have received during the previous two years, a significant portion of his or her income directly or indirectly from permit holders or applicants for a permit 16 pursuant to any federal water pollution control act as amended and as applicable 17 to this state. All members appointed on or after August 28, 2002, shall have 18 demonstrated an interest and knowledge about water quality. All members

20 appointed on or after August 28, 2002, shall be qualified by interest, education, 21training or experience to provide, assess and evaluate scientific and technical 22information concerning water quality, financial requirements and the effects of 23the promulgation of standards, rules and regulations. At the first meeting of the 24commission and at yearly intervals thereafter, the members shall select from among themselves a chairman and a vice chairman. 25

- 2. The members' terms of office shall be four years and until their successors are selected and qualified. Provided, however, that the first three members appointed shall serve a term of two years, the next three members appointed shall serve a term of four years, thereafter all members appointed shall serve a term of four years. There is no limitation on the number of terms any appointed member may serve. If a vacancy occurs the governor may appoint a member for the remaining portion of the unexpired term created by the vacancy. The governor may remove any appointed member for cause. The members of the commission shall be reimbursed for travel and other expenses actually and necessarily incurred in the performance of their duties.
- 3. The commission shall hold at least four regular meetings each year and such additional meetings as the chairman deems desirable at a place and time to be fixed by the chairman. Special meetings may be called by three members of 38 the commission upon delivery of written notice to each member of the commission. Reasonable written notice of all meetings shall be given by the 40 director to all members of the commission. Four members of the commission shall constitute a quorum. All powers and duties conferred specifically upon members of the commission shall be exercised personally by the members and not by 43 alternates or representatives. All actions of the commission shall be taken at meetings open to the public. Any member absent from six consecutive regular 46 commission meetings for any cause whatsoever shall be deemed to have resigned and the vacancy shall be filled immediately in accordance with subsection 1 of this section.

Section B. Because of the necessity to ensure proper representation on the commission, section A of this act is deemed necessary for the immediate 2 preservation of the public health, welfare, peace and safety, and is hereby declared to be an emergency act within the meaning of the constitution, and section A of this act shall be in full force and effect upon its passage and approval.
