UPDATE: Coronavirus—What You Need to Know

Not long ago, the COVID-19 virus seemed a distant threat, confined to Asia or Europe. Now, it's impacting all of us. On March 23, the first confirmed cases of COVID-19 were reported in both Buchanan and Platte counties.

We've all been asked to make major changes in our daily lives to reduce the spread of COVID-19. For all of us, these changes are disruptive, stressful and unexpected. But regardless of whether these new rules come from the president, the governor, mayors or local health agencies, all share the same goal: to slow the virus.

THE GOVERNOR'S STATEWIDE ORDER

On March 21, the governor issued an order enforcing social distancing practices statewide. All Missourians are instructed to avoid non-essential gatherings in groups larger than 10 people. Visitation to nursing homes, long-term care facilities, retirement homes or assisted living homes is prohibited, except to provide critical assistance.

As of March 23, state office buildings are now closed to the public. This includes the State Capitol as well as visitor centers at state parks and conservation areas. Visitation to Missouri's veteran's homes and correctional facilities is not allowed.

With few exceptions, the governor's order **does not** require private businesses to close. However, local health ordinances in our cities and counties require such closures, as discussed below.

LOCAL "STAY-HOME" ORDERS

In addition to the governor's executive order, both the mayors of St. Joseph and Kansas City, as well as the health department of Platte County have issued "stay-at-home" orders. Kansas City and Platte County's orders are currently scheduled to be in effect until April 24, while St. Joseph's order is set to expire April 2, unless extended. In general, residents covered by these orders are still permitted to leave their homes to go grocery shopping, go outside to exercise, pick up food at restaurants, seek medical treatment, care for family members and friends and go to work at "**essential businesses.**"

Some of the common "essential businesses" exempt from the orders, which may remain open, include:

- Health care facilities (including hospitals, doctors, dentists and pharmacies)
- Childcare facilities
- Restaurants (limited to delivery, curbside pickup, and drive-thru)
- Grocery stores
- Sanitation services
- Transportation (including gas stations)
- Financial services (including banks and insurance)
- Manufacturing
- Maintenance
- Construction
- Mailing and shipping
- Government operations (though most government offices are closed to the public)

Non-essential businesses may be required to close temporarily, unless they have "work-from-home" capabilities for employees.

THE NATIONAL RESPONSE

The federal government is setting up temporary hospitals in New York and California. The president announced he will also deploy America's two military hospital ships to relieve overrun health care facilities. Meanwhile, the federal government has been working around the clock with scientists, the FDA and infectious disease doctors to find effective treatments and develop a vaccine for COVID-19. BUSINESSES AND EMPLOYEES

Missouri businesses are now eligible for financial assistance through the U.S. Small Business Administration's Economic Injury Disaster Loan Program. Businesses may request up to \$2 million in SBA assistance to pay for fixed debts, payroll, accounts payable and other expenses that cannot be met due to the loss of business during the COVID-19 outbreak. The Missouri Department of Labor has a website (<https://labor.mo.gov/coronavirus>) for employers and individuals facing layoffs due to COVID-19. This resource provides information about unemployment benefits, including how to file claims.

TAXES AND LICENSES

The filing deadline for both state and federal tax returns has been extended from April 15 to July 15. The Missouri Department of Revenue also implemented automatic 60-day extensions for driver's license and motor vehicle registrations. Motor vehicle inspections will remain valid for an additional 60 days, as well. Driver's license testing has been suspended.

SCHOOLS

By the governor's order, public elementary and secondary schools in Missouri are closed at least through April 6. Statewide MAP tests have been canceled. ACT tests scheduled for April have been postponed until June. Schools will not be required to make up hours lost due to COVID-19, and missed days will not impact the calculation of average daily attendance for state funding. WATCH OUT FOR SCAMS AND PRICE-GOUGING

Times of crisis often bring out the worst in people. Federal prosecutors have announced charges against people claiming to have a vaccine for the virus. Watch out for scams and be vigilant about any information that does not come from a known, credible source.
