Amend SS/Senate Bill No. 812, Page 1, Section 115.277, Line 4,

2 by striking "would be" and inserting in lieu thereof the
 3 following: "is"; and further amend said bill and page, line
 4 5, by inserting an opening bracket "[" immediately before
 5 "if"; and further amend line 19, by striking "or"; and

6 Further amend said bill and section, page 2, line 22,
 7 by striking the opening bracket "["; and

8 Further amend said bill and section, page 3, line 70,
 9 by inserting after all of said line the following:

10 "115.279. 1. Application for an absentee ballot may
 11 be made by the applicant in person, or by mail, or for the
 12 applicant, in person, by his or her guardian or a relative
 13 within the second degree by consanguinity or affinity. The
 14 election authority shall accept applications by facsimile
 15 transmission and by electronic mail within the limits of its
 16 telecommunications capacity.

17 2. Each application shall be made to the election
 18 authority of the jurisdiction in which the person is or
 19 would be registered. Each application shall be in writing
 20 and shall state the applicant's name, address at which he or
 21 she is or would be registered, [his or her reason for voting
 22 an absentee ballot] whether the applicant is incapacitated
 23 or confined due to illness or physical disability or is a
 24 person who is primarily responsible for the physical care of
 25 a person who is incapacitated or confined due to illness or
 26 physical disability, the address to which the ballot is to

27 be mailed, if mailing is requested, and for absent uniformed
28 services and overseas applicants, the applicant's email
29 address if electronic transmission is requested. If the
30 [reason for the applicant voting absentee is due to the
31 reasons established under subdivision (6) of subsection 1 of
32 section 115.277] applicant is a certified participant in the
33 address confidentiality program established under sections
34 589.660 to 589.681, the applicant shall state the voter's
35 identification information provided by the address
36 confidentiality program in lieu of the applicant's name,
37 address at which he or she is or would be registered, and
38 address to which the ballot is to be mailed, if mailing is
39 requested. Each application to vote in a primary election
40 shall also state which ballot the applicant wishes to
41 receive. If any application fails to designate a ballot,
42 the election authority shall, within three working days
43 after receiving the application, notify the applicant by
44 mail that it will be unable to deliver an absentee ballot
45 until the applicant designates which political party ballot
46 he or she wishes to receive. If the applicant does not
47 respond to the request for political party designation, the
48 election authority is authorized to provide the voter with
49 that part of the ballot for which no political party
50 designation is required.

51 3. [Except as provided in subsection 3 of section
52 115.281,] All applications for absentee ballots received
53 prior to the sixth Tuesday before an election shall be
54 stored at the office of the election authority until such
55 time as the applications are processed in accordance with
56 section 115.281. No application for an absentee ballot
57 received in the office of the election authority by mail, by
58 facsimile transmission, by electronic mail, or by a guardian
59 or relative after 5:00 p.m. on the second Wednesday

60 immediately prior to the election shall be accepted by any
61 election authority. No application for an absentee ballot
62 submitted by the applicant in person after 5:00 p.m. on the
63 day before the election shall be accepted by any election
64 authority, except as provided in subsections 6, 8 and 9 of
65 this section.

66 4. Each application for an absentee ballot shall be
67 signed by the applicant or, if the application is made by a
68 guardian or relative pursuant to this section, the
69 application shall be signed by the guardian or relative, who
70 shall note on the application his or her relationship to the
71 applicant. If an applicant, guardian or relative is blind,
72 unable to read or write the English language or physically
73 incapable of signing the application, he or she shall sign
74 by mark, witnessed by the signature of an election official
75 or person of his or her own choosing. Any person who
76 knowingly makes, delivers or mails a fraudulent absentee
77 ballot application shall be guilty of a class one election
78 offense.

79 5. (1) Notwithstanding any law to the contrary, any
80 resident of the state of Missouri who resides outside the
81 boundaries of the United States or who is on active duty
82 with the Armed Forces of the United States or members of
83 their immediate family living with them may request an
84 absentee ballot for both the primary and subsequent general
85 election with one application.

86 (2) The election authority shall provide each absent
87 uniformed services voter and each overseas voter who submits
88 a voter registration application or an absentee ballot
89 request, if the election authority rejects the application
90 or request, with the reasons for the rejection.

91 (3) Notwithstanding any other law to the contrary, if
92 a standard oath regarding material misstatements of fact is

93 adopted for uniformed and overseas voters pursuant to the
94 Help America Vote Act of 2002, the election authority shall
95 accept such oath for voter registration, absentee ballot, or
96 other election-related materials.

97 (4) Not later than sixty days after the date of each
98 regularly scheduled general election for federal office,
99 each election authority which administered the election
100 shall submit to the secretary of state in a format
101 prescribed by the secretary a report on the combined number
102 of absentee ballots transmitted to, and returned by, absent
103 uniformed services voters and overseas voters for the
104 election. The secretary shall submit to the Election
105 Assistance Commission a combined report of such information
106 not later than ninety days after the date of each regularly
107 scheduled general election for federal office and in a
108 standardized format developed by the commission pursuant to
109 the Help America Vote Act of 2002. The secretary shall make
110 the report available to the general public.

111 (5) As used in this section, the terms "absent
112 uniformed services voter" and "overseas voter" shall have
113 the meaning prescribed in 52 U.S.C. Section 20310.

114 6. An application for an absentee ballot by a new
115 resident shall be submitted in person by the applicant in
116 the office of the election authority in the election
117 jurisdiction in which such applicant resides. The
118 application shall be received by the election authority no
119 later than 7:00 p.m. on the day of the election. Such
120 application shall be in the form of an affidavit, executed
121 in duplicate in the presence of the election authority or
122 any authorized officer of the election authority, and in
123 substantially the following form:

 152 application is filed pursuant to subsection 6 of this
 153 section shall immediately send a duplicate of such
 154 application to the appropriate official of the state in
 155 which the new resident applicant last resided and shall file
 156 the original of such application in its office.

157 8. An application for an absentee ballot by an
 158 intrastate new resident shall be made in person by the

159 applicant in the office of the election authority in the
 160 election jurisdiction in which such applicant resides. The
 161 application shall be received by the election authority no
 162 later than 7:00 p.m. on the day of the election. Such
 163 application shall be in the form of an affidavit, executed
 164 in duplicate in the presence of the election authority or an
 165 authorized officer of the election authority, and in
 166 substantially the following form:

193 9. An application for an absentee ballot by an
194 interstate former resident shall be received in the office
195 of the election authority where the applicant was formerly
196 registered by 5:00 p.m. on the second Wednesday immediately
197 prior to the election, unless the application is made in
198 person by the applicant in the office of the election
199 authority, in which case such application shall be made no
200 later than 7:00 p.m. on the day of the election."; and

201 Further amend said bill, pages 3-10, section 115.283,
202 by striking all of said section from the bill and inserting
203 in lieu thereof the following:

204 "115.283. 1. Each ballot envelope shall bear a
205 statement on which the voter shall state the voter's name,
206 the voter's voting address, and the voter's mailing address
207 [and the voter's reason for voting an absentee ballot]. If
208 the [reason for the voter voting absentee is due to the
209 reasons established under subdivision (6) of subsection 1 of
210 section 115.277] applicant is a certified participant in the
211 address confidentiality program established under sections
212 589.660 to 589.681, the voter shall state the voter's
213 identification information provided by the address
214 confidentiality program in lieu of the applicant's name,
215 voting address, and mailing address. On the form, the voter
216 shall also state under penalties of perjury that the voter
217 is qualified to vote in the election, that the voter has not
218 previously voted and will not vote again in the election,
219 that the voter has personally marked the voter's ballot in
220 secret or supervised the marking of the voter's ballot if
221 the voter is unable to mark it, that the ballot has been
222 placed in the ballot envelope and sealed by the voter or
223 under the voter's supervision if the voter is unable to seal
224 it, and that all information contained in the statement is
225 true. In addition, any person providing assistance to the

226 absentee voter shall include a statement on the envelope
 227 identifying the person providing assistance under penalties
 228 of perjury. Persons authorized to vote only for federal and
 229 statewide officers shall also state their former Missouri
 230 residence.

 412 during 2020, adjust the forms described in this section to
 413 account for voters voting absentee due to the reason
 414 established pursuant to subdivision (7) of subsection 1 of
 415 section 115.277.]

416 [7.] Notwithstanding any other provision of this
 417 section, any covered voter as defined in section 115.902 or
 418 persons who have declared themselves to be permanently
 419 disabled pursuant to section 115.284, otherwise entitled to
 420 vote, shall not be required to obtain a notary seal or
 421 signature on his or her absentee ballot.

422 [8.] 7. Notwithstanding any other provision of this
 423 section or section 115.291 to the contrary, the
 424 subscription, signature and seal of a notary or other
 425 officer authorized to administer oaths shall not be required
 426 on any ballot, ballot envelope, or statement required by
 427 this section if the [reason for the] voter voting absentee
 428 is [due to the reasons established pursuant to subdivision
 429 (2) or (7) of subsection 1 of section 115.277] incapacitated
 430 or confined due to illness or physical disability, including
 431 a person who is primarily responsible for the physical care
 432 of a person who is incapacitated or confined due to illness
 433 or physical disability.

434 [9.] 8. No notary shall charge or collect a fee for
435 notarizing the signature on any absentee ballot or absentee
436 voter registration.

437 [10.] 9. A notary public who charges more than the
438 maximum fee specified or who charges or collects a fee for
439 notarizing the signature on any absentee ballot or absentee
440 voter registration is guilty of official misconduct."; and

441 Further amend said bill, pages 10 to 12, section
442 115.291, by striking all of said section from the bill and
443 inserting in lieu thereof the following:

444 "115.291. 1. Upon receiving an absentee ballot by
445 mail, the voter shall mark the ballot in secret, place the
446 ballot in the ballot envelope, seal the envelope and fill
447 out the statement on the ballot envelope. The affidavit of
448 each person voting an absentee ballot shall be subscribed
449 and sworn to before the election official receiving the
450 ballot, a notary public or other officer authorized by law
451 to administer oaths, unless the voter is voting absentee due
452 to incapacity or confinement due to the provisions of
453 section 115.284, illness or physical disability, [for an
454 election that occurs during the year 2020, the voter has
455 contracted or is in an at-risk category for contracting or
456 transmitting severe acute respiratory syndrome coronavirus
457 2, as defined in section 115.277,] or the voter is a covered
458 voter as defined in section 115.902. If the voter is blind,
459 unable to read or write the English language, or physically
460 incapable of voting the ballot, the voter may be assisted by
461 a person of the voter's own choosing. Any person assisting
462 a voter who is not entitled to such assistance, and any
463 person who assists a voter and in any manner coerces or
464 initiates a request or a suggestion that the voter vote for
465 or against or refrain from voting on any question, ticket or
466 candidate, shall be guilty of a class one election offense.

467 If, upon counting, challenge or election contest, it is
468 ascertained that any absentee ballot was voted with unlawful
469 assistance, the ballot shall be rejected. [For purposes of
470 this subsection, the voters who are in an at-risk category
471 for contracting or transmitting severe acute respiratory
472 syndrome coronavirus 2 are voters who:

- 473 (1) Sixty-five years of age or older;
- 474 (2) Live in a long-term care facility licensed under
475 chapter 198;
- 476 (3) Have chronic lung disease or moderate to severe
477 asthma;
- 478 (4) Have serious heart conditions;
- 479 (5) Are immunocompromised;
- 480 (6) Have diabetes;
- 481 (7) Have chronic kidney disease and are undergoing
482 dialysis; or
- 483 (8) Have liver disease.]

484 2. Except as provided in subsection 4 of this section,
485 each absentee ballot that is not cast by the voter in person
486 in the office of the election authority shall be returned to
487 the election authority in the ballot envelope and shall only
488 be returned by the voter in person, or in person by a
489 relative of the voter who is within the second degree of
490 consanguinity or affinity, by mail or registered carrier or
491 by a team of deputy election authorities; except that
492 covered voters, when sent from a location determined by the
493 secretary of state to be inaccessible on election day, shall
494 be allowed to return their absentee ballots cast by use of
495 facsimile transmission or under a program approved by the
496 Department of Defense for electronic transmission of
497 election materials.

498 3. In cases of an emergency declared by the President
499 of the United States or the governor of this state where the

500 conduct of an election may be affected, the secretary of
501 state may provide for the delivery and return of absentee
502 ballots by use of a facsimile transmission device or
503 system. Any rule promulgated pursuant to this subsection
504 shall apply to a class or classes of voters as provided for
505 by the secretary of state.

506 4. No election authority shall refuse to accept and
507 process any otherwise valid marked absentee ballot submitted
508 in any manner by a covered voter solely on the basis of
509 restrictions on envelope type."; and

510 Further amend the title and enacting clause accordingly.
