Amend SA# SS/House Bill No. 2400, Page 21, Section 313.1006, Line 677,

2 by striking "hundred" and inserting in lieu thereof the
3 following: "million two hundred fifty"; and

4 Further amend said amendment, page 22, section
5 313.1008, lines 702-710, by striking said lines; and

6 Further amend said amendment and section, page 23,
7 lines 711-719, by striking said lines and inserting in lieu
8 thereof the following:

9 "2. (1) A licensed facility that is an excursion
10 gambling boat may also offer sports wagering through an
11 individually branded interactive sports wagering platform
12 under the brand, trade name, or another name it is doing
13 business as (d/b/a) selected by the sports wagering operator
14 or, as applicable, the interactive sports wagering platform
15 operator. A sports wagering operator may operate the
16 interactive sports wagering platform or contract with an
17 interactive sports wagering platform operator to administer
18 the interactive sports wagering platform on the licensed
19 facility's behalf.

20 (2) Subject to the approval of the commission, a
21 licensed facility that is an excursion gambling boat may
22 offer sports wagering through an additional two individually

23 branded interactive sports wagering platforms under the
24 brand, trade name, or another name it is doing business as
25 (d/b/a) selected by the sports wagering operator or, as
26 applicable, the interactive sports wagering platform
27 operator, provided that such licensed facility shall pay to
28 the commission an annual administrative fee of one million
29 two hundred fifty thousand dollars for each additional
30 interactive sports wagering platform, with such
31 administrative fee deposited in the gaming commission fund
32 established under section 313.835. A sports wagering
33 operator may operate the interactive sports wagering
34 platform or contract with one or more interactive sports
35 wagering platform operators to administer the interactive
36 sports wagering platforms on the licensed facility's behalf.

37 (3) Notwithstanding any provision of this section and
38 anything to the contrary set forth under sections 313.1000
39 through 313.1022, in no event shall sports wagering be
40 offered through more than six interactive sports wagering
41 platforms contracting with any one owner of a licensed
42 facility, directly or indirectly through any parent company,
43 subsidiary, or affiliate of such owner."; and

44 Further amend said amendment, page 34, section
45 313.1021, lines 1086-1087, by striking "equal to the rate
46 imposed pursuant to section 313.822" and inserting in lieu
47 thereof the following: "of fifteen percent"; and

48 Further amend said amendment and section, page 35, line
49 1117, by inserting after "exceed" the following: "one
50 million two hundred"; and

51 Further amend said amendment and section, page 36, line
52 1133, by striking "hundred thousand" and inserting in lieu
53 thereof the following: "million"; and further amend line
54 1136, by inserting at the end of said line the following:
55 "The amount required to be appropriated pursuant to this

56 subsection shall be increased annually by the percentage
57 increase in the Consumer Price Index for All Urban Consumers
58 for the United States, or its successor index, as such index
59 is defined and officially reported by the United States
60 Department of Labor, or its successor agency.".
