Amend SS/Senate Bill No. 115, Page 1, Section A, Line 3,

2 by inserting after all of said line the following:

3 "173.2600. 1. Any public university or college, or
 4 private university or college, that receives state funds and
 5 uses animals in research shall post on its website a written
 6 report on such animal research prior to December thirty-
 7 first of each year. This report shall be posted on the
 8 internet in a conspicuous and easily accessible location so
 9 that the members of the general assembly and the public can
 10 access a copy of the report electronically. The written
 11 report shall contain the following:

12 (1) An accounting of the total amount of funding
 13 expended for animal research by the college or university
 14 during the preceding state fiscal year. This shall include
 15 amounts of state, federal, private, and other revenue
 16 sources;

17 (2) A list of active animal research projects,
 18 including project titles, the university or college
 19 department, animal species, number and source of animals,
 20 fiscal year cost, total cost to date, funding source, and
 21 the start and end dates;

22 (3) A review of compliance with the federal Animal
 23 Welfare Act, 7 U.S.C. Section 2116 et seq., as amended, the
 24 United States Public Health Policy on Humane Care and Use of
 25 Laboratory Animals, and other applicable local, state, and
 26 federal laws, regulations, and policies governing animal

27 research. This shall include an explanation of any animal
 28 research noncompliance documented during the preceding state
 29 fiscal year and corrective actions taken in each case;

30 (4) An accounting of the number of animals by species
 31 adopted out from research laboratories during the preceding
 32 state fiscal year to animal shelters, as defined in section
 33 273.325, and the number of animals euthanized;

34 (5) Current rosters for all Institutional Animal Care
 35 and Use Committees within the college or university; and

36 (6) A detailed explanation of specific efforts by the
 37 college or university to refine, reduce, and replace the use
 38 of animals in research during the preceding state fiscal
 39 year. This shall include the number of animals by species
 40 used in research each year for the past three state fiscal
 41 years and anticipated numbers in the next fiscal year.

42 2. The use of animals in research shall include
 43 animals used in scientific research, in testing, and for
 44 experimentation purposes."; and

45 Further amend said bill, page 2, Section 340.201, line
 46 26, by inserting after all of said line the following:

47 "578.012. 1. A person commits the offense of animal
 48 abuse if he or she:

49 (1) Intentionally or purposely kills an animal in any
 50 manner not allowed by or expressly exempted from the
 51 provisions of sections 578.005 to 578.023 and 273.030;

52 (2) Purposely or intentionally causes injury or
 53 suffering to an animal; **[or]**

54 (3) Having ownership or custody of an animal knowingly
 55 fails to provide adequate care which results in substantial
 56 harm to the animal; or

57 (4) Causes injury to the sexual organs of a female dog
 58 or needlessly causes pain to a female dog during artificial
 59 insemination.

60 2. Animal abuse is a class A misdemeanor, unless the
61 defendant has previously been found guilty of animal abuse
62 or the suffering involved in subdivision (2) of subsection 1
63 of this section is the result of torture or mutilation
64 consciously inflicted while the animal was alive, in which
65 case it is a class E felony."; and

66 Further amend the title and enacting clause accordingly.
