Amend SCS/Senate Bill No. 103, Page 1, Section TITLE, Line 3,

- 2 by striking the word "automation" and inserting in lieu
- 3 thereof the following: "operations"; and
- Further amend said bill, page 4, section 476.055, line
- 5 86, by inserting after all of said line the following:
- 6 "485.060. 1. Each court reporter for a circuit judge
- 7 shall receive an annual salary of twenty-six thousand nine
- 8 hundred dollars beginning January 1, 1985, until December
- 9 31, 1985, and beginning January 1, 1986, an annual salary of
- 10 thirty thousand dollars.
- 11 2. Such annual salary shall be modified by any salary
- adjustment provided by section 476.405.
- 13 3. Beginning January 1, 2022, the annual salary, as
- modified under section 476.405, shall be adjusted upon
- 15 meeting the minimum number of cumulative years of service as
- 16 a court reporter with a circuit court of this state by the
- 17 following schedule:
- 18 (1) For each court reporter with zero to five years of
- 19 service: the annual salary shall be increased only by any
- 20 salary adjustment provided by section 476.405;
- 21 (2) For each court reporter with six to ten years of
- 22 service: the annual salary shall be increased by the whole
- 23 sum of five and one-quarter percent in addition to the
- 24 increase provided by subdivision (1) of this subsection;
- 25 (3) For each court reporter with eleven to fifteen
- 26 years of service: the annual salary shall be increased by

- 27 the whole sum of eight and one-quarter percent in addition
- 28 to the increase provided by subdivision (2) of this
- 29 subsection;
- 30 (4) For each court reporter with sixteen to twenty
- 31 years of service: the annual salary shall be increased by
- 32 the whole sum of eight and one-half percent in addition to
- 33 the increase provided by subdivision (3) of this subsection;

- 35 (5) For each court reporter with twenty-one or more
- 36 years of service: the annual salary shall be increased by
- 37 the whole sum of eight and three-quarters percent in
- 38 addition to the increase provided by subdivision (4) of this
- 39 subsection.
- 40 [A court reporter may receive multiple adjustments under
- 41 this subsection as his or her cumulative years of service
- increase, but only one percentage listed in subdivisions (1)
- 43 to (5) of this subsection shall apply to the annual salary

- 4. Salaries shall be payable in equal monthly
- 46 installments on the certification of the judge of the court
- 47 or division in whose court the reporter is employed. If
