## SENATE BILL NO. 11

## AN ACT

To amend chapter 376, RSMo, by adding thereto one new section relating to health care benefits provided by certain organizations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 376, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 376.1850, to read as
- 3 follows:
  - 376.1850. 1. As used in this section, the following
- 2 terms shall mean:
- 3 (1) "Contract for health care benefits", any contract,
- 4 certificate, or agreement entered into, offered or issued to
- 5 provide, deliver, arrange for, pay for, or reimburse any of
- 6 the costs of health care services;
- 7 (2) "Farm bureau", a nonprofit agricultural membership
- 8 organization first incorporated in this state at least one
- 9 hundred years ago, or an affiliate designated by the
- 10 nonprofit agricultural membership organization;
- 11 (3) "Health care service", the same meaning as is
- 12 ascribed to such term in section 376.1350;
- 13 (4) "Member of a farm bureau", a natural person who
- 14 pays periodic dues or fees, other than payments for a
- 15 contract for health care benefits, for membership in a farm
- 16 bureau, and the natural person's spouse or dependent
- 17 children under the age of twenty-six.
- 18 2. Contracts for health care benefits provided by a
- 19 farm bureau to a natural person in accordance with this

20	section shall not be considered insurance under the laws of
21	this state. Contracts for health care benefits provided in
22	accordance with this section shall be offered only to
23	members of a farm bureau.
24	3. Notwithstanding any provision of law to the
25	contrary, a farm bureau providing a contract for health care
26	benefits under this section shall use the services of an
27	entity permitted to provide administration services in
28	accordance with sections 376.1075 to 376.1095, and shall
29	agree in the contract with such entity to processes for
30	benefit determinations and claims payment procedures
31	comparable to those required by law for health carriers and
32	health benefit plans, including but not limited to those
33	required under sections 376.383, 376.690, and 376.1367.
34	4. The risk under contracts provided in accordance
35	with this section may be reinsured in accordance with
36	section 375.246.
37	5. Contracts for health care benefits under this
38	section shall include the following written disclaimer on
39	the contract and on all related applications and renewal
40	forms:
41	"NOTICE
42	This contract is not health insurance and is not
43	subject to laws and regulations relating to
44	insurance. This contract is not covered by the
45	Missouri Insurance Guaranty Association.".
