AN ACT

To amend chapter 376, RSMo, by adding thereto one new section relating to health care benefits provided by certain organizations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 376, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 376.1850, to read as
- 3 follows:
 - 376.1850. 1. As used in this section, the following
- 2 terms shall mean:
- 3 (1) "Contract for health care benefits", any contract,
- 4 certificate, or agreement entered into, offered or issued to
- 5 provide, deliver, arrange for, pay for, or reimburse any of
- 6 the costs of health care services;
- 7 (2) "Farm bureau", a nonprofit agricultural membership
- 8 organization first incorporated in this state at least one
- 9 hundred years ago, or an affiliate designated by the
- 10 nonprofit agricultural membership organization;
- 11 (3) "Health care service", the same meaning as is
- 12 ascribed to such term in section 376.1350;
- 13 (4) "Member of a farm bureau", a natural person who
- 14 pays periodic dues or fees, other than payments for a
- 15 contract for health care benefits, for membership in a farm
- bureau, and the natural person's spouse or dependent
- 17 children under the age of twenty-six.
- 18 2. Except as otherwise specified in subsection 3 of
- 19 this section, contracts for health care benefits provided by
- 20 a farm bureau to a natural person in accordance with this

21 section shall not be considered insurance under the laws of

- 22 this state. Contracts for health care benefits provided in
- 23 accordance with this section shall be offered only to
- 24 members of a farm bureau.
- 25 3. Notwithstanding any provision of law to the
- 26 contrary, a farm bureau providing a contract for health care
- 27 benefits under this section shall use the services of an
- 28 entity permitted to provide administration services under
- 29 sections 376.1075 to 376.1095, and shall agree in the
- 30 contract to processes for benefit determinations and claims
- 31 payment procedures comparable to those required by law for
- 32 health carriers and health benefit plans, provided that
- 33 nothing in this section shall be construed to give the
- 34 department of commerce and insurance supervisory or
- 35 enforcement authority over contracts offered or provided in
- 36 accordance with this section or require any filing with the
- 37 department of commerce and insurance by a farm bureau.
- 38 4. The risk under contracts provided in accordance
- 39 with this section may be reinsured in accordance with
- 40 section 375.246.
- 41 5. Contracts for health care benefits under this
- 42 section shall include the following written disclaimer on
- 43 the contract and on all related applications and renewal
- 44 forms:
- 45 "NOTICE
- 46 This contract is not health insurance and is not
- 47 subject to laws and regulations relating to
- 48 insurance. This contract is not covered by the
- 49 Missouri Insurance Guaranty Association.".
