AN ACT

To repeal sections 115.365, 115.603, 115.619, and 115.621, RSMo, and to enact in lieu thereof four new sections relating to county commission district political party committees.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 115.365, 115.603, 115.619, and

- 2 115.621, RSMo, are repealed and four new sections enacted in
- 3 lieu thereof, to be known as sections 115.365, 115.603, 115.619,
- 4 and 115.621, to read as follows:

115.365. 1. The nominating committee authorized to

- 2 select a candidate for nomination or election to office
- 3 pursuant to section 115.363 shall be one of the following:
- 4 (1) To select a candidate for [county]countywide
- 5 office, the nominating committee shall be the county
- 6 committee of the party, provided that in the case a vacancy
- 7 in the county commission to be filled by a special election,
- 8 or to select a candidate for county commissioner, county
- 9 council, or county legislator, the nominating committee
- 10 shall be the county commission district committee;
- 11 (2) To select a candidate for state representative,
- 12 the nominating committee shall be the legislative district
- 13 committee of the party;
- 14 (3) To select a candidate for state senator, the
- 15 nominating committee shall be the senatorial district
- 16 committee of the party;

- 17 (4) To select a candidate for circuit court judge not 18 subject to the provisions of Article V, Section 25 of the 19 State Constitution, the nominating committee shall be the
- (5) To select a candidate for representative in
 Congress, the nominating committee shall be the
 congressional district committee of the party;

judicial district committee of the party;

- 24 (6) To select a candidate for statewide office, the 25 nominating committee shall be the state committee of the 26 party.
- 2. After any decennial redistricting, the nominating
 committee shall be composed from the new districts, and the
 new district lines shall be used in the selection of a
 candidate; provided, however, that members of nominating
 committees for candidates for special elections to fill
 vacancies conducted pursuant to section 21.130 shall be from
 the old districts.
- 115.603. Each established political party shall have a 2 state committee, a congressional district committee for each congressional district in the state, a judicial district 3 committee for each circuit judge district in the state not 4 5 subject to the provisions of Article V, Section 25 of the 6 state constitution, a senatorial district committee for each 7 senatorial district in the state, a legislative district 8 committee for each legislative district in the state, a 9 county commission district committee for each county commission district, county council district, and county 10 legislative district in each county in the state, and a 11 12 county committee for each county in the state, except any city not within a county which shall have a city committee 13
- 14 in lieu of a county committee.

115.619. 1. A legislative district committee shall

- 2 consist of the precinct, ward, or township committeeman and
- 3 committeewoman from such precincts, wards, or townships
- 4 included in whole or in part of the legislative district.
- 5 There shall be elected from the membership of each
- 6 legislative district committee a chairman and a vice
- 7 chairman, one of whom shall be a woman and one of whom shall
- 8 be a man, and each legislative district at the same time
- 9 shall elect a secretary and a treasurer, one of whom shall
- 10 be a woman and one of whom shall be a man, but who may or
- 11 may not be members of the legislative district committee.
- 12 Party state committees may provide for voting by proxy and
- 13 for weighted or fractional voting.
- 14 2. The congressional, senatorial, or judicial
- 15 committee of a district which is composed of:
- 16 (1) One or more whole counties; or
- 17 (2) One or more whole counties and part of one or more
- 18 counties;
- 19 shall consist of the county committee chair and vice chair
- 20 of each county within the district and the committeeman and
- 21 committeewoman of each legislative district committee within
- 22 the district.
- 3. The congressional, senatorial, or judicial
- 24 committee of a district which consists of:
- 25 (1) Parts of one or more counties;
- 26 (2) Part of a city not within the county;
- 27 (3) A whole city not within a county; or
- 28 (4) Part of a city not within a county and parts of
- 29 one or more counties;

- 30 shall consist of the committeemen and committeewomen of the
- 31 precinct, ward, or township included in whole or in part of
- 32 the district and the chair and vice chair of each
- 33 legislative district committee within the district in whole
- 34 or in part.
- 35 4. A county commission district committee shall
- 36 consist of the precinct, ward, or township committeeman and
- 37 committeewoman from such precincts, wards, or townships
- 38 included in whole or in part of the county commission
- 39 district, county council district, or county legislative
- 40 district, as the case may be. There shall be elected from
- 41 the membership of each county commission district committee
- 42 a chair and a vice chair, one of whom shall be a woman and
- 43 one of whom shall be a man, and each county commission
- 44 district committee at the same time shall elect a secretary
- 45 and a treasurer, one of whom shall be a woman and one of
- 46 whom shall be a man, but who may or may not be members of
- 47 the county commission district committee. Party state
- 48 committees may provide for voting by proxy and for weighted
- 49 or fractional voting.
 - 115.621. 1. Notwithstanding any other provision of
- 2 this section to the contrary, any legislative, senatorial,
- 3 or judicial district committee that is wholly contained
- 4 within a county or a city not within a county may choose to
- 5 meet on the same day as the respective county or city
- 6 committee. All other committees shall meet as otherwise
- 7 prescribed in this section.
- 8 2. The members of each county committee shall meet at
- 9 the county seat not earlier than two weeks after each
- 10 primary election but in no event later than the third
- 11 Saturday after each primary election, at the discretion of
- 12 the chairman at the committee. In each city not within a

13 county, the city committee shall meet on the same day at the

14 city hall. In all counties of the first, second, and third

- 15 classification, the county courthouse shall be made
- 16 available for such meetings and any other county political
- 17 party meeting at no charge to the party committees. In all
- 18 cities not within a county, the city hall shall be made
- 19 available for such meetings and any other city political
- 20 party meeting at no charge to the party committees. At the
- 21 meeting, each committee shall organize by electing two of
- 22 its members, a man and a woman, as chair and vice chair, and
- 23 a man and a woman who may or may not be members of the
- 24 committee as secretary and treasurer.
- 25 3. The members of each congressional district
- 26 committee shall meet at some place and time within the
- 27 district, to be designated by the current chair of the
- 28 committee, not earlier than five weeks after each primary
- 29 election but in no event later than the sixth Saturday after
- 30 each primary election. The county courthouse in counties of
- 31 the first, second and third classification in which the
- 32 meeting is to take place, as designated by the chair, shall
- 33 be made available for such meeting and any other
- 34 congressional district political party committee meeting at
- 35 no charge to the committee. At the meeting, the committee
- 36 shall organize by electing one of its members as chair and
- 37 one of its members as vice chair, one of whom shall be a
- 38 woman and one of whom shall be a man, and a secretary and a
- 39 treasurer, one of whom shall be a woman and one of whom
- 40 shall be a man, who may or may not be members of the
- 41 committee.
- 4. The members of each legislative district committee
- 43 shall meet at some place and date within the legislative
- 44 district or within one of the counties in which the

legislative district exists, to be designated by the current 45 chair of the committee, not earlier than three weeks after 46 47 each primary election but in no event later than the fourth Saturday after each primary election. 48 The county courthouse in counties of the first, second and third classification in 49 50 which the meeting is to take place, as designated by the 51 chair, shall be made available for such meeting and any 52 other legislative district political party committee meeting at no charge to the committee. At the meeting, the 53 54 committee shall organize by electing two of its members, a man and a woman, as chair and vice chair, and a man and a 55 woman who may or may not be members of the committee as 56 57 secretary and treasurer. The members of each senatorial district committee 58 shall meet at some place and date within the district, to be 59 designated by the current chair of the committee, if there 60 is one, and if not, by the chair of the congressional 61 62 district in which the senatorial district is principally 63 located, not earlier than four weeks after each primary election but in no event later than the fifth Saturday after 64 each primary election. The county courthouse in counties of 65 the first, second and third classification in which the 66 meeting is to take place, as so designated pursuant to this 67 subsection, shall be made available for such meeting and any 68 other senatorial district political party committee meeting 69 70 at no charge to the committee. At the meeting, the 71 committee shall organize by electing one of its members as chair and one of its members as vice chair, one of whom 72 shall be a woman and one of whom shall be a man, and a 73 74 secretary and a treasurer, one of whom shall be a woman and one of whom shall be a man, who may or may not be members of 75

- 77 The members of each senatorial district shall also meet at some place within the district, to be designated by 78 79 the current chair of the committee, if there is one, and if not, by the chair of the congressional district in which the 80 senatorial district is principally located, on the Saturday 81 after each general election or concurrently with the 82 election of senatorial officers, if designated or not 83 84 objected to by the chair of the congressional district where the senatorial district is principally located. At the 85 86 meeting, the committee shall proceed to elect two registered voters of the district, one man and one woman, as members of 87 the party's state committee. 88
- 89 7. The members of each judicial district may meet at some place and date within the judicial district or within 90 one of the counties in which the judicial district exists, 91 92 to be designated by the current chair of the committee or the chair of the congressional district committee, not 93 94 earlier than six weeks after each primary election but in no 95 event later than the seventh Saturday after each primary 96 election. The county courthouse in counties of the first, second and third classification in which the meeting is to 97 take place, as so designated pursuant to this subsection, 98 shall be made available for such meeting and any other 99 100 judicial district political party committee meeting at no 101 charge to the committee. At the meeting, the committee 102 shall organize by electing two of its members, a man and a 103 woman, as chair and vice chair, and a man and a woman who may or may not be members of the committee as secretary and 104 105 treasurer.
 - 8. The members of each county commission district shall meet at some place and date within the county commission district, to be designated by the current chair

of the committee or, if there is none, the chair of the county committee, on September 25, 2023, and thereafter, not earlier than seven weeks after each primary election but in no event later than the eighth Saturday after each primary election. The county courthouse in counties of the first, second, and third classification in which the meeting is to take place, as so designated pursuant to this subsection, shall be made available for such meeting and any other county commission district political party committee meeting at no charge to the committee. At the meeting, the committee shall organize by electing two of its members, a man and a woman, as chair and vice chair, and a man and a woman who may or may not be members of the committee as secretary and treasurer.
