## **AN ACT**

To amend chapter 407, RSMo, by adding thereto one new section relating to the sale of certain lighters.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 407, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 407.021, to read as
- 3 follows:
  - 407.021. 1. For the purposes of this section, the
- 2 following terms shall mean:
- 3 (1) "Counterfeit lighter", any lighter that infringes
- 4 on the intellectual property rights of any citizen of the
- 5 United States or any entity that is protected by any federal
- 6 or state intellectual property law;
- 7 (2) "Lighter", any electrical or mechanical device
- 8 that:
- 9 (a) Operates using any type of fuel or power source,
- 10 including, but not limited to, butane, isobutene or another
- 11 liquid fuel, or source of electrical energy, including but
- 12 not limited to all types of batteries; and
- 13 (b) Is typically used to light cigarettes, cigars or
- 14 pipes, candles, charcoal or gas grills, or fireplaces;
- 15 (3) "Novelty lighter", lighters that are recognized as
- 16 appealing to or intended for use of children under five and:
- 17 (a) That physically resemble in shape a cartoon
- 18 character, toy, gun, watch, musical instrument, vehicle, toy
- 19 animal, food or beverage or similar articles; or

- 20 (b) That play musical notes, or have flashing lights
- 21 for entertainment; provided, however, that "novelty
- 22 lighters" do not include standard disposable or refillable
- 23 lighters that are printed or decorated with logos, labels,
- 24 decals, artwork, emblems, engravings, etchings,
- 25 inscriptions, or heat shrinkable sleeves;
- 26 (4) "Unsafe lighter":
- 27 (a) Any disposable or refillable lighters that do not
- 28 comply with American Society for Testing and Materials
- 29 Standard F400-20, as amended; and
- 30 (b) Any grill or utility lighters that do not comply
- 31 with American Society for Testing and Materials Standard
- 32 **F2201-20**, as amended.
- Except as provided in subsection 3 of this section,
- 34 no person shall offer or sell any novelty lighters,
- 35 counterfeit lighters, or unsafe lighters in this state,
- 36 including, but not limited to, by way of providing a free
- 37 sample to a person in this state, regardless of whether such
- 38 person is offering or selling such lighters on a retail
- 39 basis, wholesale basis, online, or in person.
- 40 3. The provisions of this section shall not be
- 41 construed to prohibit:
- 42 (1) The interstate transportation of counterfeit
- 43 lighters or unsafe lighters through this state; or
- 44 (2) The storage of counterfeit lighters or unsafe
- 45 lighters in any distribution center or warehouse located in
- 46 this state if such distribution center or warehouse is
- 47 closed to the public and does not distribute or sell, at
- 48 retail, such lighters to the public.
