## SENATE BILL NO. 105

## AN ACT

To repeal section 263.070, RSMo, and to enact in lieu thereof one new section relating to nonnative invasive plants.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 263.070, RSMo, is repealed and one new

- 2 section enacted in lieu thereof, to be known as section 263.070,
- 3 to read as follows:
  - 263.070. 1. A schedule of fees to defray the cost of
- 2 inspecting greenhouses, nurseries, nursery dealers, nursery
- 3 stock, plants, plant products and other materials is hereby
- 4 established and shall be listed in the rules made pursuant
- 5 to sections 263.010 to 263.180. This fee schedule may be
- 6 revised from time to time to more accurately reflect the
- 7 actual cost of these inspections.
- 8 2. Greenhouse inspection shall be optional and any
- 9 grower of greenhouse plants who may desire or find need for
- 10 a certificate of greenhouse inspection may obtain semiannual
- 11 inspection of his greenhouse, premises and plants, by making
- 12 application to the state entomologist. This semiannual
- 13 inspection and certification of greenhouses shall be
- 14 performed under the same general provisions as apply to the
- 15 annual inspection of nurseries. Greenhouse inspection
- 16 certificates shall expire on November thirtieth of each year.
- 17 3. All nurseries in this state shall be inspected at
- 18 least once each year to ascertain whether they are infested
- 19 or infected with plant pests and shall comply with the

- affidavit requirements under paragraph (d) of subdivision 20 21 (1) of subsection 5 of this section. Upon full payment of 22 the fee and submission of the affidavit each nurseryman shall receive a written notice of the findings of such 23 inspection along with a nursery inspection certificate; 24 25 except that, the state entomologist may withhold certification of a nursery pending eradication of extremely 26 27 serious or abundant plant pests or weeds of such nature which would prevent the adequate inspection of such 28 29 nursery. This certificate shall be used in connection with the shipment or movement of any nursery stock shown to be 30 apparently free of harmful and destructive plant pests or 31 32 other nursery stock from which harmful and destructive plant pests have been eliminated. All nursery inspection 33 certificates shall expire on September thirtieth of each 34 35 year. Each nursery shall be allowed one retail sales outlet 36 per certificate. Additional outlets shall require separate 37 nursery dealer registration-inspection certificates. 38 the findings of the annual inspection of a nursery shall in the opinion of the state entomologist warrant such action, 39 additional inspections of the nursery may be made and the 40 nursery may be charged a fee sufficient to cover the cost of 41
- 43 By notice in writing the state entomologist may require a nurseryman to hold any variety or any amount of 44 45 nursery stock for inspection or reinspection by quarantining 46 such nursery stock whenever such action is necessary to determine that it is free from pests or to allow time to 47 48 eradicate any such pests. The state entomologist may 49 further order the removal from sale and the treatment or 50 destruction of any nursery stock infested or infected with especially injurious pests or nursery stock which is not 51 52 viable or is in such damaged or desiccated condition as to

- be incapable of reasonable growth. No compensation shall be paid for any stock ordered destroyed.
- 5. (1) Each nursery dealer, before selling or
- offering for sale or otherwise distributing nursery stock
- 57 within this state, shall annually obtain a nursery dealers'
- 58 registration-inspection certificate for each individual
- 59 location from which the dealer sells or offers for sale
- 60 nursery stock. Each nursery dealer shall make application
- on forms to be provided by the state entomologist for each
- 62 individual location, which shall include:
- (a) The name and complete address of the nursery
- 64 dealer's place of business for which such certificate is
- 65 requested;
- (b) A declaration that applicant will obtain and
- 67 distribute only inspected and certified nursery stock; [and]
- (c) An up-to-date listing of all sources from which
- 69 [he] the nursery dealer secures nursery stock; and
- 70 (d) An affidavit that the nursery dealer shall not
- 71 knowingly and intentionally import, export, buy, sell,
- 72 transport, distribute, or propagate any viable plant portion
- 73 or seeds of:
- 74 a. Climbing euonymus (Euonymus fortune variety
- 75 Coloratus), all varieties and cultivars of Japanese
- 76 honeysuckle (Lonicera japonica), or all varieties and
- 77 cultivars of Sericea lespedeza (Lespedeza cuneata), or
- 78 perilla mint (perilla frutescens) on or after January 1,
- **79** 2027; or
- 80 b. Burning bush (Euonymus alatus Compactus) or all
- 81 varieties and cultivars of Callery pear (Pyrus calleryana)
- 82 on or after January 1, 2029.
- 83 (2) Each nursery dealer shall pay, at the time of
- 84 making application, the annual registration-inspection fee

- as set forth in the rules made pursuant to sections 263.010 to 263.180.
- 87 (3) All nursery dealer registration-inspection88 certificates shall expire on September thirtieth of each89 year.

- (4) The state entomologist may inspect or cause to be inspected the premises of any nursery dealer including any sales yard, packing shed, nursery stock on hand or equipment, for the presence of dangerous and destructive plant pests which may be disseminated on nursery stock.
- 95 By notice in writing the state entomologist may require a nursery dealer to hold any variety or any amount 96 97 of nursery stock by quarantining such nursery stock whenever such action is necessary to determine that it is free from 98 pests or to allow time to eradicate any such pests. 99 100 state entomologist may further order the removal from sale 101 and the treatment or destruction of any nursery stock 102 infested or infected with especially injurious pests, or 103 nursery stock which is not viable or is in such damaged or 104 desiccated condition as to be incapable of reasonable 105 growth. No compensation shall be paid for any stock ordered 106 destroyed.
- 107 7. Any person in need of a special inspection and 108 certification of nursery stock, other plants or plant 109 products may upon request to the state entomologist have 110 same inspected for plant pests. A fee sufficient to cover 111 the cost of such inspection or certificate, or both, may be charged. Upon completion of the inspection and payment of 112 113 the fee, a certificate of inspection shall be issued 114 provided the plants or plant products are free of harmful plant pests. The state entomologist may enter into 115 agreements with various persons or companies, to carry out 116

- the requirements of this state and importing states or
  countries.
- 119 8. All moneys received for any inspection fee or other
- 120 receipts under this law shall be deposited in the state
- 121 treasury and shall be subject to appropriation by the
- 122 general assembly.
