## **AN ACT**

To amend chapter 227, RSMo, by adding thereto one new section relating to the department of transportation's fiber network.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 227.675, to read as
- 3 follows:
  - 227.675. 1. The provisions of this section shall be
- 2 known and may be cited as the "Department of Transportation
- 3 Fiber Network Expansion Act".
- 4 2. For purposes of this section, the following terms
- 5 mean:
- 6 (1) "Commission", the Missouri highways and
- 7 transportation commission;
- 8 (2) "Department", the Missouri department of
- 9 transportation.
- 3. The commission may enter into public-private
- 11 partnerships with private broadband internet service
- 12 providers to expand and further develop the department's
- 13 fiber network.
- 14 4. The commission shall prioritize expansion and
- 15 development under this section in unserved areas and
- 16 underserved areas, as such terms are defined in section
- 17 **620.2450.**

- 18 5. The commission shall use a competitive procurement
- 19 process to form public-private partnerships under this
- 20 section. The commission shall publish a public notice of
- 21 the commission's request for proposals, including any
- 22 deadline for submission of such proposals, which shall be
- 23 published once a week for two consecutive weeks in:
- 24 (1) A newspaper of general circulation in the city
- 25 where the proposed project is located;
- 26 (2) At least one technology industry trade publication
- 27 that is nationally distributed; and
- 28 (3) Such other publications or manner as the
- 29 commission may determine.
- 30 6. The commission shall ensure that at least twenty-
- 31 five percent of the workforce fulfilling the contracts
- 32 awarded under this section belongs to a racial minority
- group, as such term is defined in section 37.013.
- 7. As part of a contract award under this section, the
- 35 private partnering entity may use the excess fiber capacity
- 36 to provide internet services as long as the services
- 37 provided meet the state minimum standard for broadband set
- 38 by the department of economic development.
- 39 8. The commission may promulgate any rules to
- 40 implement the provisions of this section. Any rule or
- 41 portion of a rule, as that term is defined in section
- 42 536.010, that is created under the authority delegated in
- 43 this section shall become effective only if it complies with
- 44 and is subject to all of the provisions of chapter 536 and,
- 45 if applicable, section 536.028. This section and chapter
- 46 536 are nonseverable and if any of the powers vested with
- 47 the general assembly pursuant to chapter 536 to review, to
- 48 delay the effective date, or to disapprove and annul a rule
- 49 are subsequently held unconstitutional, then the grant of

50 rulemaking authority and any rule proposed or adopted after

51 August 28, 2025, shall be invalid and void.
