AN ACT

To repeal section 376.1222, RSMo, and to enact in lieu thereof one new section relating to insurance coverage of prostheses.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 376.1222, RSMo, is repealed and one

- 2 new section enacted in lieu thereof, to be known as section
- 3 376.1222, to read as follows:

376.1222. 1. Any health insurance policy through the

- 2 Medicaid program pursuant to chapter 208, the children's
- 3 health insurance program pursuant to sections 208.631 to
- 4 208.660, and any health care plans issued to employees under
- 5 the Missouri consolidated health care plan established
- 6 pursuant to chapter 103 that are delivered, issued for
- 7 delivery, continued or renewed in this state on or after
- 8 January 1, 2004, shall provide coverage for prostheses and
- 9 expenses for scalp hair prostheses worn for hair loss
- 10 suffered as a result of alopecia areata or alopecia totalis
- 11 for persons eighteen years of age or younger who are covered
- 12 under a policy, program or plan pursuant to this section.
- 13 The benefits required by this subsection shall expire when
- 14 the covered person reaches eighteen years of age.
- 15 2. Any health benefit plan delivered, issued for
- delivery, continued, or renewed in this state on or after
- 17 January 1, 2025, shall provide coverage for prostheses and

expenses for scalp hair prostheses worn for hair loss suffered as a result of cancer treatment.

- 20 3. For purposes of this section, the following terms 21 mean:
- 22 (1) "Health benefit plan", the same meaning as is 23 ascribed to such term in section 376.1350;
- 24 (2) "Prostheses", artificial appliances used to
 25 replace lost natural structures;
- 26 [(2)] (3) "Scalp hair prostheses", artificial
 27 substitutes for scalp hair that are made specifically for a
 28 particular individual.
- 29 The coverage required by this section shall not be more than a maximum benefit amount of two hundred 30 dollars per calendar year or exceed a lifetime maximum 31 benefit amount of three thousand two hundred dollars for 32 those persons who select a more permanent scalp hair 33 prosthesis. A person may request a one-time expenditure of 34 up to three thousand two hundred dollars. The benefits 35 36 required by this section shall expire when total benefits paid reach three thousand two hundred dollars [or when such 37 person listed in subsection 1 of this section reaches 38 eighteen years of age]. 39
 - [4.] 5. The health care service required by this section shall not be subject to any greater deductible or copayment than other similar health care services provided by the policy, program, or plan.
- 44 [5.] 6. Nothing in this section shall prohibit a
 45 health insurer or health benefit plan from providing
 46 coverage that is greater than or more favorable to persons
 47 than the coverage provided by this section.
