AN ACT

To repeal section 578.012, RSMo, and to enact in lieu thereof two new sections relating to animal abuse, with penalty provisions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 578.012, RSMo, is repealed and two new

- 2 sections enacted in lieu thereof, to be known as sections
- 3 578.006 and 578.012, to read as follows:
 - 578.006. 1. This section shall be known and may be
- 2 cited as "Brown's Law" in commemoration of veterinarian
- 3 Senator Doc Brown, an animal caregiver and protector of both
- 4 pets and farm animals.
- 5 2. A person commits the offense of making a malicious
- 6 false report of animal abuse if:
- 7 (1) The person purposely makes a report to a law
- 8 enforcement agency or an applicable government agency
- 9 alleging the abuse of any animal in a manner punishable
- 10 under section 578.012;
- 11 (2) The person knows that such a report is false;
- 12 (3) The person makes the report with the purpose of
- disrupting, harassing, causing a monetary loss to, or
- 14 disturbing the peace of the owner of the animal; and
- 15 (4) Such report causes a disruption, harassment,
- 16 monetary loss, or disturbance of the owner of the animal.
- 17 3. The offense of making a malicious false report of
- 18 animal abuse is a class C misdemeanor.

- 19 It shall be an absolute defense for a prosecution of the offense of making a malicious false report of animal 20 21 abuse if the reporting party reported an incident of animal 22 abuse out of a good faith, reasonable belief that an animal The defendant shall have the burden of 23 was being abused. 24 injecting this defense under this subsection. defendant asserts that his or her report of animal abuse was 25 26 made from a good faith, reasonable belief that an animal was 27 being abused, the state shall have the burden to prove 28 beyond a reasonable doubt that the defendant did not have a 29 good faith, reasonable belief that such a report was true.
- 578.012. 1. A person commits the offense of animal abuse if he or she:
- 3 (1) Intentionally or purposely kills an animal in any 4 manner not allowed by or expressly exempted from the 5 provisions of sections 578.005 to 578.023 and 273.030;
- 6 (2) Purposely or intentionally causes injury or7 suffering to an animal; or
- 8 (3) Having ownership or custody of an animal knowingly
 9 fails to provide adequate care which results in substantial
 10 harm to the animal.
- 2. Animal abuse is a class A misdemeanor, unless the defendant has previously been found guilty of animal abuse or the suffering involved in subdivision (2) of subsection 1 of this section is the result of torture [or], mutilation [consciously], starvation, or dehydration knowingly inflicted while the animal was alive, in which case it is a class E felony.
