AN ACT

To repeal sections 347.740, 351.127, 355.023, 356.233, 359.653, 400.9-528, and 417.018, RSMo, and to enact in lieu thereof seven new sections relating to fees collected by the secretary of state.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 347.740, 351.127, 355.023, 356.233, 2 359.653, 400.9-528, and 417.018, RSMo, are repealed and seven 3 new sections enacted in lieu thereof, to be known as sections 4 347.740, 351.127, 355.023, 356.233, 359.653, 400.9-528, and 5 417.018, to read as follows:

347.740. The secretary of state may collect an 2 additional fee of five dollars on each and every fee 3 required in this chapter. All fees collected as provided in 4 this section shall be deposited in the state treasury and 5 credited to the secretary of state's technology trust fund 6 account. **[The provisions of this section shall expire on 7 December 31, 2026.]**

351.127. The secretary of state may collect an 2 additional fee of five dollars on each and every fee 3 required in this chapter, provided that the secretary of 4 state may collect an additional fee of ten dollars on each 5 corporate registration report fee filed under section 6 351.122. All fees collected as provided in this section 7 shall be deposited in the state treasury and credited to the 8 secretary of state's technology trust fund account. **[The**

9 provisions of this section shall expire on December 31,
10 2026.]

355.023. The secretary of state may collect an
2 additional fee of five dollars on each and every fee
3 required in this chapter. All fees collected as provided in
4 this section shall be deposited in the state treasury and
5 credited to the secretary of state's technology trust fund
6 account. [The provisions of this section shall expire on
7 December 31, 2026.]

356.233. The secretary of state may collect an
2 additional fee of five dollars on each and every fee
3 required in this chapter. All fees collected as provided in
4 this section shall be deposited in the state treasury and
5 credited to the secretary of state's technology trust fund
6 account. [The provisions of this section shall expire on
7 December 31, 2026.]

359.653. The secretary of state may collect an
2 additional fee of five dollars on each and every fee
3 required in this chapter. All fees collected as provided in
4 this section shall be deposited in the state treasury and
5 credited to the secretary of state's technology trust fund
6 account. [The provisions of this section shall expire on
7 December 31, 2026.]

400.9-528. The secretary of state may collect an
2 additional fee of five dollars on each and every fee paid to
3 the secretary of state as required in chapter 400.9. All
4 fees collected as provided in this section shall be
5 deposited in the state treasury and credited to the
6 secretary of state's technology trust fund account. [The
7 provisions of this section shall expire on December 31,
8 2026.]

417.018. The secretary of state may collect an
2 additional fee of five dollars on each and every fee
3 required in this chapter. All fees collected as provided in
4 this section shall be deposited in the state treasury and
5 credited to the secretary of state's technology trust fund
6 account. [The provisions of this section shall expire on
7 December 31, 2026.]
