## **AN ACT**

To repeal section 537.046, RSMo, and to enact in lieu thereof one new section relating to childhood sexual abuse actions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

- Section A. Section 537.046, RSMo, is repealed and one new
- 2 section enacted in lieu thereof, to be known as section 537.046,
- 3 to read as follows:
  - 537.046. 1. As used in this section, the following
- 2 terms mean:
- 3 (1) "Childhood sexual abuse", any act committed by the
- 4 defendant, or an act committed by an individual if the
- 5 defendant's tortious conduct causes such act to occur,
- 6 against the plaintiff which act occurred when the plaintiff
- 7 was under the age of eighteen years and which act would have
- 8 been a violation of section 566.030, [566.040, 566.050]
- **566.031**, **566.032**, **566.034**, 566.060, [566.070, 566.080,
- 10 566.090] **566.061**, **566.062**, **566.064**, **566.067**, **566.068**,
- 11 566.069, 566.071, 566.083, 566.086, 566.093, 566.095,
- 12 566.100, [566.110, or 566.120] **566.101**, **566.209**, **566.210**,
- 13 **566.211**, or [section] 568.020;
- 14 (2) "Injury" or "illness", either a physical injury or
- 15 illness or a psychological injury or illness. A
- 16 psychological injury or illness need not be accompanied by
- 17 physical injury or illness.
