## **AN ACT**

To amend chapter 210, RSMo, by adding thereto one new section relating to emergency notification systems, with penalty provisions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 210, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 210.1017, to read as
- 3 follows:
  - 210.1017. 1. There is hereby created a statewide
- 2 program called the "Ebony Alert System" referred to in this
- 3 section as the "system" to aid in the identification and
- 4 location of an abducted or missing Black youth.
- 5 2. For the purposes of this section, "abducted or
- 6 missing Black youth" means a Black individual whose
- 7 whereabouts are unknown and who is:
- 8 (1) Less than twenty-five years of age and reasonably
- 9 believed to be the victim of the offense of kidnapping or
- 10 kidnapping in the first degree as defined by section 565.110
- 11 as determined by local law enforcement;
- 12 (2) Reasonably believed to be the victim of the
- offense of child kidnapping as defined by section 565.115 as
- 14 determined by local law enforcement;
- 15 (3) Less than twenty-five years of age and at least
- 16 fourteen years of age and who, if under the age of fourteen,
- 17 would otherwise be reasonably believed to be a victim of

18 child kidnapping as defined by section 565.115 as determined

- 19 by local law enforcement; or
- 20 (4) Reasonably believed to be a victim of an offense
- of trafficking pursuant to sections 566.206, 566.209,
- 22 **566.210**, or **566.211**.
- 3. The department of public safety shall develop
- 24 regions to provide the system. The department of public
- 25 safety shall coordinate local law enforcement agencies and
- 26 public commercial television and radio broadcasters to
- 27 provide an effective system. In the event that a local law
- 28 enforcement agency opts not to set up a system and an
- 29 abduction occurs within the jurisdiction, it shall notify
- 30 the department of public safety who shall notify local media
- 31 in the region.
- 32 4. The Ebony alert system shall include all state
- 33 agencies capable of providing urgent and timely information
- 34 to the public together with broadcasters and other private
- 35 entities that volunteer to participate in the dissemination
- 36 of urgent public information. At a minimum, the Ebony alert
- 37 system shall include the department of public safety,
- 38 highway patrol, department of transportation, department of
- 39 health and senior services, and Missouri lottery.
- 40 5. Participation in an Ebony alert system is entirely
- 41 at the option of local law enforcement agencies and
- 42 federally licensed radio and television broadcasters.
- 43 6. Any person who knowingly makes a false report that
- 44 triggers an alert pursuant to this section is guilty of a
- 45 class A misdemeanor.
