AN ACT

To amend chapter 171, RSMo, by adding thereto one new section relating to the Ten Commandments in schools.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 171, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 171.022, to read as
- 3 follows:
 - 171.022. 1. As used in this section, "Ten
- 2 Commandments" means the following text:
- 3 "The Ten Commandments
- 4 I AM the LORD thy God.
- 5 Thou shalt have no other gods before me.
- 6 Thou shalt not make to thyself any graven images.
- 7 Thou shalt not take the Name of the Lord thy God in
- 8 vain.
- 9 Remember the Sabbath day, to keep it holy.
- Honor thy father and thy mother, that thy days may be
- 11 long upon the land which the Lord thy God giveth thee.
- 12 Thou shalt not kill.
- 13 Thou shalt not commit adultery.
- 14 Thou shalt not steal.
- 15 Thou shalt not bear false witness against thy neighbor.
- 16 Thou shalt not covet thy neighbor's house, thou shalt
- 17 not covet thy neighbor's wife, nor his manservant, nor his

18 maidservant, nor his cattle, nor anything that is thy

- 19 neighbor's."
- 20 2. Beginning on January 1, 2026, each school
- 21 district's school board and charter school's governing board

- 22 shall display the Ten Commandments in each building and
- 23 classroom under the school board's or governing board's
- 24 jurisdiction, subject to at least the following requirements:
- 25 (1) The nature of such display shall be determined by
- 26 each school board and governing board;
- 27 (2) Such display shall be composed of, at a minimum, a
- 28 poster or framed document that is at least eleven inches by
- 29 fourteen inches; and
- 30 (3) The text of the Ten Commandments shall be the
- 31 central focus of the poster or framed document and shall be
- 32 printed in a large, easily readable font.
- 33 3. (1) A school board or governing board may spend
- 34 the board's moneys or donated moneys to purchase the
- 35 displays.
- 36 (2) A school board or governing board may accept
- 37 donated displays.
- 38 (3) This section shall not be construed to require a
- 39 school board or governing board to spend the board's moneys
- 40 to purchase displays.
- 4. The state board of education may promulgate all
- 42 necessary rules and regulations for the administration of
- 43 this section. Any rule or portion of a rule, as that term
- 44 is defined in section 536.010, that is created under the
- 45 authority delegated in this section shall become effective
- 46 only if it complies with and is subject to all of the
- 47 provisions of chapter 536 and, if applicable, section
- 48 536.028. This section and chapter 536 are nonseverable and
- 49 if any of the powers vested with the general assembly

- 50 pursuant to chapter 536 to review, to delay the effective
- 51 date, or to disapprove and annul a rule are subsequently
- 52 held unconstitutional, then the grant of rulemaking
- authority and any rule proposed or adopted after August 28,
- 54 2025, shall be invalid and void.
