AN ACT

To repeal section 568.045, RSMo, and to enact in lieu thereof one new section relating to the offense of endangering the welfare of a child in the first degree, with penalty provisions.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 568.045, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 568.045, 2 3 to read as follows: 1. A person commits the offense of 568.045. 2 endangering the welfare of a child in the first degree if he or she: 3 (1)Knowingly acts in a manner that creates a 4 substantial risk to the life, body, or health of a child 5 less than seventeen years of age; [or] 6 7 (2)Knowingly engages in sexual conduct with a person 8 under the age of seventeen years over whom the person is a 9 parent, guardian, or otherwise charged with the care and custody; 10 Knowingly encourages, aids or causes a child less 11 (3) 12 than seventeen years of age to engage in any conduct which violates the provisions of chapter 571 or 579; or 13

EXPLANATION-Matter enclosed in bold-faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law.

(4) In the presence of a child less than seventeen
years of age or in a residence where a child less than
seventeen years of age resides, unlawfully manufactures or
attempts to manufacture compounds, possesses, produces,
prepares, sells, transports, tests or analyzes any of the
following: fentanyl, carfentanil, amphetamine, or
methamphetamine, or any [of its analogues] analogue thereof.

21 2. The offense of endangering the welfare of a child22 in the first degree is a class D felony unless the offense:

(1) Is committed as part of an act or series of acts performed by two or more persons as part of an established or prescribed pattern of activity, or where physical injury to the child results, or the offense is a second or subsequent offense under this section, in which case the offense is a class C felony;

(a) The offense is a class B felony; and

32 (b) A person sentenced under this subdivision shall
 33 not be eligible for conditional release or parole until he
