ASSUMPTION

Officials of the **Office of State Courts Administrator** assume there would be no fiscal impact on the Courts.

Oversight received no response from Franklin County, however, Oversight assumes on December 31, 2014, which is beyond the scope of this fiscal note, Franklin County Circuit Courts would have to discontinue charging an additional \$10 fee on court cases. Oversight assumes the repeal of Section 488.429 is cleanup language and would have no fiscal impact.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This substitute sets an expiration date of December 31, 2014 on the additional \$10 fee which Circuit Courts in Franklin County charge on all civil cases except cases concerning adoption and small claims. This proposal also repeals Section 488.429 RSMo., which was doubly enacted in a previous legislation session. One of the enacted sections has an expiration date and one does not. This proposal repeals the one which has an expiration date.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
