**FISCAL IMPACT - Small Business**

The proposal may make more accredited speech language pathologists and audiologists available for employment in small businesses providing or needing those services.

## DESCRIPTION

This proposal modifies provisions relating to the licensing of speech-language pathologist and audiologists. Currently, educational degrees must be from an institution accredited or approved by the Council on Academic Accreditation of the American Speech-Language-Hearing Association. The proposal authorizes the board of healing arts to accept educational degrees from institutions approved by other board-approved accrediting agencies.


The proposal also exempts persons with audiology clinical doctoral degrees from current clinical fellowship requirements which are needed in order to become licensed.

Finally, the president of the Missouri Academy of Audiology is responsible for submitting names to the boarding of healing arts when a vacancy occurs on a commission for one of the licensed audiologist positions.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
