FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State** (SOS) assume this proposal would require publication of the proposed constitutional amendment. Statewide newspaper publication of state statutes cost approximately \$1,289 per column inch based on an estimate provided by the Missouri Press Service x 3 for multiple printings as required by the Constitution and state statute = \$3,867 per column inch. SOS estimates the total number of inches for this amendment to be 10 inches, including title header and certification paragraph. (\$3,867 x 10 inches = \$38,670). These costs are based on 2004 figures and are subject to change.

Oversight assumes the election would be held in conjunction with the November 2006 general election rather than at a special election.

Officials from the Office of the State Treasurer, the Missouri House of Representatives, and the Office of Administration, Missouri Ethics Commission, assume this proposal would have no impact on their organizations.

<u>ASSUMPTIONS</u> (continued)

Officials from the **Missouri Senate** assume this proposal could result potential savings (cost avoidance) associated with this legislation depending on whether the number of legislative days per session are impacted. A reduction in the number of session days would result in a corresponding decrease in statutory cost. The "in-session" days have statutorily mandated costs associated with them in the form of statutory mileage payments (one round trip per week at the state mileage rate) and statutory per diem payments (currently \$76.80 per day) when answering a daily roll call.

Oversight assumes there could be a cost reduction from reducing the number of legislative days per session; however, the proposal does not include any reduction in or limitation of the number of legislative days. Oversight has not included any savings from reducing the number of legislative days in this fiscal note.

Officials from the **Office of Administration**, **Division of Budget and Planning** (BAP) assume this proposal would result in a small savings to BAP related to the costs of printing the Executive Budget every other year (approx. \$9,200). In addition, there should be savings to each state agency related to their costs of printing annual budget request books.

Oversight assumes there would be unknown savings to the state each biennium from the reduction in Executive Budget printing costs, and from the reduction in agency printing costs. Oversight assumes there would be a corresponding but smaller increase in costs due to the need for more emergency and supplemental budget requests. If the proposal is approved by the voters in the November 2006 general election, the first legislative session required to approve two-year budgets would begin in January 2007. The first legislative session dedicated to general laws and supplementary appropriations would begin in January 2008. Oversight has shown cost reductions to the General Revenue Fund related to budget publication of more than \$9,200 in FY 2008, and notes there could be additional savings in subsequent years from a more general reduction in budget preparation activity.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed constitutional amendment, if approved by the voters, would adopt a two-year budget and appropriation cycle.

The first legislative session of each general assembly would be used exclusively for the enactment of appropriations laws except for emergency legislation where health, welfare, and safety requires legislative action. The general assembly would enact appropriation laws to remain in effect for two fiscal years.

The second legislative session would be used exclusively for the enactment of general laws except for the enactment of supplemental appropriations laws if necessary.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
