ASSUMPTION

Officials from the **Boone County Sheriff's Department** state their department presently has its sex offender registry online. Therefore, the proposal would have no fiscal impact on their agency.

Oversight assumes the proposal is permissive and would have no fiscal impact. However, if the chief law enforcement officer of the county elects to establish a searchable registered sexual offender web page on the Internet, the county may experience a fiscal impact. Since the language is permissive, Oversight assumes no impact.

Officials from the **Greene County Sheriff's Office, Jackson County Sheriff's Office, and St. Louis County Police Department** did not respond to Oversight's request for fiscal impact.

The proposal would allow the chief law enforcement agency of a county to maintain a searchable sexual offender registry website on the Internet.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
