### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Boone County Sheriff's Department** state their department presently has its sex offender registry online. Therefore, the proposal would have no fiscal impact on their agency.

**Oversight** assumes the proposal is permissive and would have no fiscal impact. However, if the chief law enforcement officer of the county elects to establish a searchable registered sexual offender web page on the Internet, the county may experience a fiscal impact. Since the language is permissive, Oversight assumes no impact.

Officials from the **Greene County Sheriff's Office**, Jackson County Sheriff's Office, and **St. Louis County Police Department** did not respond to Oversight's request for fiscal impact.

## FISCAL IMPACT - Small Business
