**FISCAL ANALYSIS**

**ASSUMPTION**

Officials with the **Department of Transportation (MoDOT)** assume that signs designating the “Carver Prairie Drive” shall be paid for by local political subdivisions where the road is located and, thus, assume no fiscal impact to MoDOT for such designation.

MoDOT assumes that their agency may incur labor costs to relocate existing “George Washington Carver Memorial Highway” signs to the new location, but that such costs would be absorbed by department resources already in place or planned.

**Oversight** assumes all costs for the “Carver Prairie Drive” designation will be paid for by the City of Diamond, resulting in a unknown negative fiscal impact (not expected to exceed \$1,000) to the city.

DESCRIPTION


This legislation removes the portion of I-44 in Jasper County from the designation of “George Washington Carver Memorial Highway”. This portion was already designated as the “Congressman Gene Taylor Highway” prior to the creation of the “George Washington Carver Memorial Highway”.

This proposal, however, includes within the “George Washington Carver Memorial” designation a portion of U.S. Highway 71 contained in Jasper County. The act also designates a portion of State Route V in Newton County as the “Carver Prairie Drive”.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
