FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration – Administrative Hearing Commission, – Division of Budget and Planning, Department of Economic Development – Division of Professional Registration, Department of Health and Senior Services, and the Office of the Secretary of State** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of Administration – Division of Risk Management** assume the proposal has the potential for costs to the State Legal Expense Fund. There are no claims to date. Therefore, costs cannot be determined at this time.

Officials from the **Office of the Attorney General (AGO)** did not respond to Oversight’s request for fiscal impact. However, in response to a similar proposal (TAFP CCS for HS for SCS for SB 393, 1651-08 from the 2001 session), officials assumed any costs incurred by their agency resulting from the legislation could be absorbed.

FISCAL IMPACT - Small Business

DESCRIPTION

Currently, certain dentists who perform dental primary care and preventive health services are covered by the state legal expense fund. The proposed legislation would add extractions to the definition of “dental primary care and preventive health services.”

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
