FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Insurance (INS)** state Property and Casualty insurers who choose to exclude fire as a result of terrorism will be required to amend their policy forms. Policy form amendments must be submitted to the INS for review along with a \$50 filing fee. The total number of commercial property and casualty insurers is 398. The INS assumes one-time revenues to the Insurance Dedicated Fund of \$19,900 (398 insurers X \$50).

This proposal will result in an increase in total state revenue.

FISCAL IMPACT - Small Business

This proposal could directly impact small businesses if they incur losses due directly or indirectly to terrorism.

DESCRIPTION

This proposal allows commercial casualty insurance policies to exclude coverage for loss by fire or other perils caused by terrorism.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
