FISCAL ANALYSIS

ASSUMPTION

Officials with the **Department of Revenue (DOR)** stated that DOR currently operates Motor Vehicle and Branch Offices in both St. Louis and Kansas City. The department's operating costs for these offices include personal services and expense and equipment. The Office of Administration administers the fringe benefits and leasing costs associated with these offices. This proposal would no longer require the department to operate this offices.

Based on FY04 data, the Kansas City Branch Office employs 17.5 employees. The operating budget for that office is:

\$396,234 Personal Service

\$ 27,807 Expense and Equipment

\$160,356 Fringe Benefits (Office of Administration costs)

\$ 41,720 Leasing Expenses (Office of Administration costs)

\$626,117 Total Operating Costs

<u>ASSUMPTION</u> (continued)

Based on FY04 data, the South Kingshighway Branch Office (St. Louis) employs 20 employees. The operating budget for that office is:

\$421,545 Personal Service \$ 52,279 Expense and Equipment \$170,599 Fringe Benefits (Office of Administration costs) \$ 59,763 Leasing Expenses (Office of Administration costs) \$704,186 Total Operating Costs

Total Operating Costs for Kansas City and St. Louis Branch Offices is \$1,330,303. For purposes of this fiscal note, the department of revenue assumes all costs will be avoided from the general revenue fund.

Based on FY04 data, the Kansas City Branch Office collected \$409,275 in processing fees and the South Kingshighway Branch Office collected \$579,954 in processing fees. The processing fees would no longer be collected; thus, decreasing revenues as follows:
