### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Transportation**, **Department of Revenue**, **Department of Public Safety** – **Division of Fire Safety**, – **Director's Office**, – **Missouri State Water Patrol**, – **Missouri State Highway Patrol**, and the **Department of Insurance** assume the proposal would have no fiscal impact on their agencies.

In response to a similar proposal from the current session (HB 362, LR # 1070-01), officials from the **Office of the Attorney General** assumed any potential costs arising from this proposal can be absorbed within existing resources.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

In response to a similar proposal from the current session (HB 362, LR # 1070-01), officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

### FISCAL IMPACT - Small Business

### **DESCRIPTION**

The proposed legislation would provide that when a court enters an order of expungement for arrest records or alcohol-related driving offenses, the expunged records shall be confidential and only available to the parties or by court order for good cause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
