FISCAL IMPACT - Small Business

This proposal could directly impact small business counseling organizations.

DESCRIPTION

This proposal modifies the definition of the practice of professional counseling and creates new definitions for "assessment", "consulting", "counseling treatment interventions", "diagnosis", "referral", and "research". The practice of professional counseling shall include certain types of individual, family and marriage counseling and psychotherapy, assessment, crisis intervention, diagnosis of persons with mental, emotional and behavioral disorders, consulting, research and referral.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
