FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed legislation states that a beneficiary deed that provides for the transfer of property upon the last to die of two or more grantors of the deed will be effective if all owners of that property are grantors under the deed. This proposal will apply to all beneficiary deeds, including those executed prior to August 28, 2005.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
