DESCRIPTION


This proposal authorizes the Department of Economic development to contract with a higher education institution to establish a distant dental hygienist learning program. Such program must meet standards established by the council on dental accreditation.

This act sunsets in six years.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
