FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Revenue (DOR)** state this proposal exempts applicants for purple heart license plates from paying the one time \$15 specialty plate fee. DOR assumes the proposal has minimal administrative impact and can be implemented with no additional resources. DOR will change the appropriate systems associated with the fees for purple heart plates, procedures, forms and letters.

DOR states that in Fiscal Year 2005, they issued 194 new purple heart license plates. 194 new purple heart license plates x \$15 each results in \$2,910 of revenue from the new purple heart plates. Assuming the volume of new plates does not increase or decrease, there would be a decrease of \$2,910 of revenue each year. DOR states this revenue is divided between Highway Funds, cities and counties as follows;
