FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Corrections, Department of Public Safety** – **Missouri State Highway Patrol,** and the **Office of the State Public Defender** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

Officials from the **Boone County Sheriff's Department** assume the proposal has the potential to generate some revenues. Although no schedule has been discussed, officials assume the reimbursement would likely mirror reimbursement from DWI cases. Currently Boone County Sheriff's Department recovers \$14.51 per hour for 3 hours spent on each DWI conviction. However, revenues generated from prostitution convictions would be minimal as very few prostitution arrests are made by the agency.

<u>ASSUMPTION</u> (continued)

Officials from the **City of Kansas City** assume the legislation would have an undeterminable beneficial fiscal impact as a result of recovery of some costs involved in the prosecution and incarceration of the persons accused of certain prostitution related offenses. The amount is undeterminable because of the unknown numbers of arrests and incarcerations and the unknown, but presumably very low instances of recovery.

Officials from the **Springfield Police Department** assume the proposal could generate revenues of approximately \$500 to \$1,000 per year, depending on the number of arrests.

Officials from the **St. Louis Metropolitan Police Department** assume the proposal would have a positive revenue impact on their department.

Oversight assumes local law enforcement agencies could experience an increase in revenues in the form of reimbursement of the costs associated with arrests in prostitution related offenses. Oversight assumes the cumulative revenues generated to be less than \$100,000 per fiscal year.

Officials from the Columbia Police Department, Greene County Sheriff's Department, and the St. Louis County Police Department did not respond to Oversight's request for fiscal impact.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

The proposed legislation allows the court to order, in addition to other penalties, a convicted person to reimburse law enforcement for reasonable costs associated with arrests involving violations of county or municipal ordinances relating to prostitution, including the cost of blood testing.

The proposal also changes the definition in Section 567.010, RSMo, of "prostitution-related offense" to include any violation of state law or county or municipal ordinance related to prostitution, patronizing prostitution, or promoting prostitution.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
