This proposal may have an impact on small businesses that employ interior designers as the registration requirements are reduced.


#### DESCRIPTION

Currently, in order to register as an interior designer, an applicant must have his or her experience verified by five client references and five industry references. This proposal requires that such experience be verified by two client references and three industry references.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
