# FISCAL ANALYSIS

# **ASSUMPTION**

Officials from the **Department of Corrections**, **Department of Public Safety** – **Missouri State Highway Patrol**, – **Capitol Police**, – **Division of Fire Safety**, – **Missouri State Water Patrol**, and the **Office of the State Public Defender** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

Officials from the **Boone County Sheriff's Department (BCSD)** state they process an average of 160 permits to acquire a concealable firearm each month. They charge \$10 for each permit issued. BCSD estimates average revenues of \$19,200 annually. If citizens are no longer required to obtain a permit to acquire a concealable firearm, these monies will be lost.

# <u>ASSUMPTION</u> (continued)

Officials from the **St. Louis Metropolitan Police Department** assume they would experience a significant loss due to the proposal, but cannot quantify the amount of loss.

**Oversight** assumes the loss in revenues to county law enforcement agencies and the St. Louis Metropolitan Police Department for no longer issuing permits to acquire concealable firearms could exceed \$100,000 per fiscal year.

Officials from the Greene County Sheriff's Department, Jackson County Sheriff's Department, and the St. Louis County Police Department did not respond to Oversight's request for fiscal impact.

#### **DESCRIPTION**

The proposed legislation eliminates the requirement that a person must obtain a concealable firearm permit before acquiring a handgun. Currently, it is a class A misdemeanor to have such a gun without a permit.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
