FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Agriculture, Office of Administration, Department of Natural Resources, Department of Corrections, Department of Social Services, Department of Public Safety (DPS) - Director's Office, DPS - Missouri State Highway Patrol, DPS - Missouri National Guard, and Office of the Governor** assume the proposal will have no fiscal impact on their organizations.

Officials from the **Office of Attorney General** assume any potential costs arising from this proposal can be absorbed with existing resources.

Officials from the **Department of Health and Senior Services (DOH)** state the proposal would not be expected to fiscally impact the operations of the DOH. If a fiscal impact were to result, funds to support the program would be sought through the appropriations process.

Officials from the **City of Dexter and St. Louis University** did not respond to our request for a statement of fiscal impact.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposal authorizes the Governor to convey state property in Pettis County to the Heart of Missouri Girl Scout Council, convey property in St. Francois County to the Farmington American Legion Post 416, and convey property owned by the state in Stoddard County to the Stoddard County Common Sewer District Number 1 with conveyance of property by the City of Dexter to the Missouri National Guard.

The proposal authorizes the Governor to sell, transfer, grant, or convey property known as Troop C in St. Louis, Missouri, property known as Church Farm in Cole County, property in Lincoln County, property known as Greenberry Farms in Jefferson City, property at Greene Valley State School, and property known as Troop A in Lee's Summit, Missouri.

In addition, the proposal provides for the Department of Agriculture building located at 1616 Missouri Boulevard in Jefferson City to be designated as the "George Washington Carver Building".


This proposal has an emergency clause.
