FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator** assume there will be no fiscal impact on the Courts.

Officials from the following divisions of **Department of Economic Development** stated there would be no fiscal impact to their respective divisions: **Public Service Commission**, **Public Counsel**, **Finance**, and **Credit Unions**.

Officials from the **Office of Attorney General (AGO)** assumed that AGO would receive new complaints from consumers who believe they have been victimized by having spyware installed on their computers. Because the AGO anticipates that the number of additional complaints would be relatively small, the AGO assumed that costs can be absorbed. If, however, the number of new complaints exceeds 100 per year, the AGO may seek additional appropriations to handle the increased workload.

In response to the introduced version of this proposal, officials from the **Office of Prosecution Services** state this proposal will not have a significant fiscal impact on county prosecutors, although it may lead to an increase in prosecutions/caseloads.

Officials from the Office of State Public Defender did not respond to a request for fiscal note.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed legislation establishes the Consumer Protection Against Computer Spyware Act, making it illegal for an unauthorized user to intentionally modify the settings of a computer belonging to or leased to a consumer, collect personally identifiable information from the computer, prevent an authorized user's reasonable efforts to block the installation of or disable installed software, remove or disable security software installed on the computer, or take control of the consumer's computer by transmitted commercial electronic mail or a computer virus from the consumer's computer.

A manufacturer or retailer of computer equipment shall not be liable under this proposal to the extent that the manufacturer or retailer is providing third-party branded software loaded on the equipment they are manufacturing or selling.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
