Under the provisions of this proposed legislation, no teacher, administrator, or school board in any public school district in this state shall be prohibited from reading or posting in a public school building, classroom, or at a school event any excerpts or portions including, but not limited to, a list of documents and verses related to American and Missouri history, the civil rights movement, and patriotism.

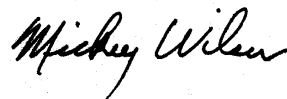
This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
