#### FISCAL IMPACT - Small Business

## **DESCRIPTION**

This proposal modifies the law regarding St. Louis Police Officers.

As of August 28, 2006, the Board of Police Commissioners would have the authority to compute and establish the annual salary of each member of the St. Louis City police force without receiving prior authorization from the General Assembly.

This act contains an emergency clause and has an effective date of June 26, 2006.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.

<sup>\*</sup> Oversight assumes this proposal is permissive, and any increase in salaries would be determined by the Board of Police Commissioners.
