ASSUMPTION

Officials from the following agencies stated this proposed legislation would have no fiscal impact on their agencies: Commissioner of Administration - Division of Accounting, Budget and Planning, Information Technology Services; Office of State Treasurer; Department of Economic Development - Public Service Commission and Office of Public Counsel; Department of Natural Resources; Department of Transportation; Office of Secretary of State; Department of Public Safety; Department of Agriculture - Agriculture and Small Business Authority; Coordinating Board for Higher Education; Department of Elementary and Secondary Education.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed legislation authorizes certain state and local public entities and political corporations of the state to enter into agreements with other parties that provide for the fixing of the costs of certain commodities, such as the cost of purchasing fuel, electricity and natural gas. If such public entity or political corporation has bonds or other obligations that are outstanding or to be issued, the public entity or political corporation may enter into agreements providing for payments based on levels of, or changes in, interest rates. Such agreements may contain payment, security, default, remedy and other terms as determined by the public entity or political corporation after giving consideration to the creditworthiness of the other party.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
