#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

### **DESCRIPTION**

This act requires any candidate for County Treasurer to be at least twenty-one years of age and a resident of the state and county for at least one year prior to the general election. The candidate must also be a registered voter and shall be current in the payment of personal and business taxes. Upon election, the person must continue to reside in the county during his or her tenure.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
