## **ASSUMPTION**

Officials of the **Missouri Department of Transportation** assume no state or local fiscal impact.

Officials of the **Director of Administration of St. Louis County** stated that the County does currently participate in two transportation development districts; however, the County is not the direct recipient of an TDD funds. Officials assume the change in voting calculations would not affect their revenues. Officials assume no fiscal impact.

Officials of Cass County and Jefferson County assume no fiscal impact.

**Oversight** assumes this proposal affects the way in which votes are to be counted in Transportation Development District elections. **Oversight** assumes this proposal adds no new duties, or requires the expenditure of additional funds, therefore, **Oversight** assumes no state or local fiscal impact.

## **DESCRIPTION**

This act gives property owners one vote per acre when electing directors for a transportation development district. Under current law, qualified voters get one vote regardless of property ownership
