FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

The act prohibits certain local regulations pertaining to the registration, sale, storage, and use of seeds and other propagules but does not preempt local zoning ordinances governing the physical location of seed facilities. The act asserts that no state regulation shall be more restrictive than federal regulations pertaining to research, development, and use of seed technologies.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
